PURSUANT to section 71 of the Private Investigators and Security Guards Act 1974, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Private Investigators and Security Guards Regulations 1975, Amendment No. 5, and shall be read together with and deemed part of the Private Investigators and Security Guards Regulations 1975* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

2. Multiple notices in respect of applications for licence—The principal regulations are hereby amended by inserting, after regulation 5, the following regulation:

“5A. Where 2 or more persons have applied to the Registrar for a licence, or for renewal of a licence, they may give combined public notice, as required by section 21 (2) or section 33(5) of the Act, in form 5A in the First Schedule to these regulations.”

3. Amendments to First Schedule—(1) The First Schedule to the principal regulations is hereby amended by omitting from the heading to form 5 the expression “Section 20 (2)”, and substituting the expression “Section 21 (2)”.

(2) The First Schedule to the principal regulations is hereby amended by inserting, after form 5, the form set out in the Schedule to these regulations.

COMBINED NOTICE OF APPLICATION FOR LICENCE
(or FOR RENEWAL OF LICENCE) UNDER THE
PRIVATE INVESTIGATORS AND SECURITY GUARDS ACT 1974

TAKE NOTICE that each of the persons described in the first column of the Schedule to this notice has applied to the Registrar of Private Investigators and Security Guards for a licence or for renewal of a licence, as specified in the second column of that Schedule, of the type specified in the third column of that Schedule.

Any person wishing to object to the grant of any of these applications must give written notice of his or her objection to the Registrar so as to reach the Registrar not later than 1 month after the date of the first publication of this notice. No objection can be made otherwise than on one of the grounds set out in section 23 (2) of the Act. A copy of a notice of objection must be served on the applicant, at the address given below, within 7 days after the notice is filed with the Registrar.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Private Investigators and Security Guards Regulations 1975. Section 21 (2) of the Private Investigators and Security Guards Act 1975 requires public notice to be given, by publication on 2 separate occasions in a newspaper, of any application for a licence. Section 33 (5) of that Act also applies that requirement to any application for renewal of a licence.

These regulations allow 2 or more applicants to give a combined public notice, relating to all licences sought by any of them. A new form 5A is prescribed for this purpose.

In addition, a minor amendment is made to existing form 5, with the effect that the heading now cross-refers to the correct section.
