# NOTICE

**1. Title and commencement**—(1) This notice may be cited as the Penal Institutions (Mount Eden Prison) Notice 1999.

(2) This notice takes effect from 29 July 1999.

**2. Mount Eden Prison**—The land and the parts of the buildings described in the Schedule are declared to be a prison, to be known as Mount Eden Prison.

**3. Revocation**—The Penal Institutions (Mount Eden Prison) Notice 1998\* is revoked.

### SCHEDULE

### MOUNT EDEN PRISON

All that parcel of land in the North Auckland Land District containing 4.8783 hectares, more or less, being part Allotments 105 and 177, Section 6, Suburbs of Auckland, being more particularly shown marked 'A' on Survey Office Plan 51947, and being all the land comprised and described in certificate of title No. 90D/600, North Auckland Registry; and

The cell block contained within the building complex known as the Auckland High Court situated on all that parcel of land in the North Auckland Land District containing 6188 square metres, more or less, being Allotment 12, Section 2, City of Auckland, and Allotment 13, Section 12, City of Auckland, and being all the land comprised and described in certificate of title No. 88C/879, North Auckland Registry; and

The cell block contained within the building complex known as the Auckland District Court situated on all that parcel of land in the North Auckland Land District containing 3232 square metres, more or less, being Lot 1 on Deposited Plan 107968, and being part Allotments 11, 12, 13, 14, and 15, Section 21, City of Auckland, and being all the land comprised and described in certificate of title No. 60A/1051, North Auckland Registry.

#### EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which takes effect from 29 July 1999, is made under the Penal Institutions Act 1954. It declares the land and parts of buildings described in the Schedule to be a prison, to be known as Mount Eden Prison. The parts of buildings described in the Schedule are the cell blocks at the Auckland High Court and the Auckland District Court.

This notice replaces a previous notice relating to Mount Eden Prison. The only change is that the land described in the Schedule no longer includes land declared to be a periodic detention centre by the Periodic Detention Centre (Boston Road (Mount Eden)) Notice 1999.
