THE PENAL INSTITUTIONS (PRE-RELEASE HOSTELS) NOTICE 1981

PURSUANT to section 4 of the Penal Institutions Act 1954 and section 3 of the Penal Institutions Amendment Act 1978, and, in respect only of clause 9 (2) of the notice, pursuant to section 4 (2) of the Criminal Justice Amendment Act 1962, the Minister of Justice hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Penal Institutions (Pre-release Hostels) Notice 1981.

(2) This notice shall take effect from the 9th day of April 1981.

2. Mount Albert Pre-release Hostel—(1) The land described in the First Schedule to this notice is hereby declared to be a prison pre-release hostel, to be known as the Mount Albert Pre-release Hostel.

(2) The land described in the First Schedule to this notice is hereby declared to be excluded from the prison known as the Mount Eden Prison*.

(3) Clause 4 (1) of the Penal Institutions Notice 1974 and the First Schedule to that notice are hereby revoked.

3. Mount Eden Pre-release Hostel—(1) The land described in the Second Schedule to this notice is hereby declared to be a prison pre-release hostel, to be known as the Mount Eden Pre-release Hostel.

(2) The Penal Institutions Notice 1972⁺ is hereby revoked.

4. Avenell House Pre-release Hostel—(1) The land described in the Third Schedule to this notice is hereby declared to be a prison pre-release hostel and a youth prison pre-release hostel and a borstal pre-release hostel, to be known as the Avenell House Pre-release Hostel.

(2) The Penal Institutions Notice 1978⁺ is hereby revoked.

5. Christchurch Pre-release Hostel—(1) The land described in the Fourth Schedule to this notice is hereby declared to be a prison pre-release hostel, to be known as the Christchurch Pre-release Hostel.

(2) The Penal Institutions Notice 1967§ is hereby revoked.

6. Hamilton Pre-release Hostel—(1) The land described in the Fifth Schedule to this notice is hereby declared to be a youth prison pre-release hostel and a borstal pre-release hostel, to be known as the Hamilton Pre-release Hostel.

(2) The Penal Institutions Notice 1963* is hereby revoked.

7. Austin Street Pre-release Hostel—(1) The land described in the Sixth Schedule to this notice is hereby declared to be a youth prison pre-release hostel and a borstal pre-release hostel, to be known as the Austin Street Pre-release Hostel.

(2) The land described in the Sixth Schedule to this notice is hereby declared to be excluded from the borstal institution known as the Invercargill Borstal Institution[†].

(3) The Penal Institutions Notice 1968 is hereby revoked.

8. Kensington Street Pre-release Hostel—(1) The land described in the Seventh Schedule to this notice is hereby declared to be a prison pre-release hostel, to be known as the Kensington Street Pre-release Hostel.

(2) The land described in the Seventh Schedule to this notice is hereby declared to be excluded from the prison known as the Wellington Prison[‡].

(3) Clause 6 of the Penal Institutions Notice 1974 and the Fourth Schedule to that notice are hereby revoked.

9. Shelley Beach Road Pre-release Hostel—(1) The land described in the Eighth Schedule to this notice is hereby declared to be a youth prison pre-release hostel and a borstal pre-release hostel, to be known as the Shelley Beach Road Pre-release Hostel.

(2) Clause 2 (5) of the Work Centres Notice 1975§, and the First Schedule to that notice so far as it relates to the land fifthly described in it, are hereby revoked.
