THE PENAL INSTITUTIONS NOTICE 1955

Pursuant to the Penal Institutions Act 1954, the Minister of Justice hereby gives the following notice.

NOTICE

- 1. This notice may be cited as the Penal Institutions Notice 1955.
- 2. (1) The land described in the First Schedule hereto is hereby declared to be a borstal institution, known as the Arohata Borstal Institution.
- (2) The land described in the First Schedule hereto is hereby also declared to be a prison, known as the Arohata Prison.
- 3. The land described in the Second Schedule hereto is hereby declared to be a prison, known as the Dunedin Prison.
- 4. The land described in the Third Schedule hereto is hereby declared to be a prison, known as the Napier Prison.
- 5. The land described in the Fourth Schedule hereto is hereby declared to be a prison, known as the New Plymouth Prison.
- 6. The land described in the Fifth Schedule hereto is hereby declared to be a prison, known as the Paparua Prison.
- 7. The land described in the Sixth Schedule hereto is hereby declared to be a prison, known as the Picton Prison.
- 8. The land described in the Seventh Schedule hereto is hereby declared to be a prison, known as the Tongariro Prison Farm.
- 9. The land described in the Eighth Schedule hereto is hereby declared to be a prison, known as the Wanganui Prison.
- 10. This notice is in substitution for the Proclamations specified in the Ninth Schedule hereto.

SCHEDULES

FIRST SCHEDULE

Arohata Borstal Institution and Arohata Prison

ALL that area in the Wellington Land District situated in Block VII, Belmont Survey District, containing 60 acres and 2 perches, more or less, being part of Section 32, Porirua District, and being the whole of the land comprised and described in certificate of title, Volume 352, folio 258, Wellington Registry.

Also all that area in the Wellington Land District situated in Block VII, Belmont Survey District, containing 81 acres 1 rood and 7 perches, more or less, being part of Section 34, Porirua District, and being the whole of the land comprised and described in certificate of title, Volume 427, folio 142, Wellington Registry.

SECOND SCHEDULE

DUNEDIN PRISON

ALL that area situated in the Otago Land District and the City of Dunedin containing 3 roods 2.65 perches, more or less, being part of Reserve 3 and part of Section 37, Block XV, Town of Dunedin, bounded towards the north-west by Dunbar Street, 237.22 links; towards the north-east by part of Reserve 3, 84.87 links; towards the south-east by the said part of Reserve 3, 13.41 links; again towards the north-east by the said part of Reserve 3 and part Section 37, 214.37 links; again towards the south-east by Castle Street and Lower High Street, 396.35 links; towards the south-west by part of Section 37, 61.2 links; again towards the south-east by the said part of Section 37, 09 of a link; again towards the south-west by said part of Section 37, 37.6 links; again towards the north-west by part of Reserve 3, 60.05 links; and again towards the south-west by the said part of Reserve 3, 70.2 links to the place of commencement; be all the aforesaid linkages more or less: as the same is delineated on the plan marked P.D. 1933/16/8 deposited in the Head Office of the Department of Justice, Wellington, and thereon bordered red. (S.O. Plan 858 Tn.)

THIRD SCHEDULE

NAPIER PRISON

ALL that area in the Hawke's Bay Land District containing 1 rood 4.64 perches, more or less, being Town Section 715, Town of Napier. (S.O. Plan 2493.)

Also all that area in the Hawke's Bay Land District containing 4 acres 1 rood 4.22 perches, more or less, being Suburban Section 675, Town of Napier. (S.O. Plan 2493.)

FOURTH SCHEDULE

NEW PLYMOUTH PRISON

ALL that area in the Taranaki Land District containing 12 acres 1 rood and 33 perches, more or less, being Section 2344 and part of Section 2343, Town of New Plymouth.

Also all that area in the Taranaki Land District containing 6 acres 1 rood and 3 perches, more or less, being Section 2345, Town of New Plymouth, and part of Section W, New Plymouth Town Belt, and being Lot 1, D.P. 1775, and Lot 2A, D.P. 1843.

As the same are delineated on the plan marked J. 7/6/- deposited in the Head Office of the Department of Justice, Wellington, and thereon bordered red. (S.O. Plans 1072 and 3263.)

FIFTH SCHEDULE

Paparua Prison

ALL that area in the Canterbury Land District, in the Paparua County, containing 1,390 acres 1 rood and 31 perches, more or less, being Sections 3, 4, 5, 7, 8, and 13 and part of Section 6, Drayton Settlement, Reserve 2531, parts of Reserve 702 and Rural Section 36831, and part of Rural Section 4886, situated in Block XII, Rolleston Survey District, and Block IX, Christchurch Survey District, bounded as follows: Commencing at the north-eastern corner of Reserve 325 in Block XII, Rolleston Survey District, and bounded towards the north generally by West Coast Road, 29684 links and 7646 links, Reserve 2530, again by West Coast Road, 100 links, Part Reserve 702 comprised in certificate of title Volume 343, folio 30, Lot 3, Deposited Plan 3415, and Lots 1 and 2, Deposited Plan 7627; towards the south-east by Haskett Road; towards the south generally by a public road forming the northern boundaries of Lots 2 and 1, Deposited Plan 16841, and Reserve 3962; towards the north-east by Reserve 3962 and Barter Road; towards the south-east by Sections 20 to 16 (inclusive), Drayton Settlement; towards the south-west generally by Sections 15, 14, and 12 to 9 (inclusive), Drayton Settlement; again towards the south-east by Section 9 aforesaid; again towards the southwest by Church Road; again towards the south-east by Newton Road; again towards the south-west by part Rural Section 5721, and Rural Sections 8913 and 7715 comprised in certificate of title, Volume 177, folio 147, and Rural Section 7467; towards the north-west by Sections 1 and 2, Drayton Settlement; and towards the west generally by Church Road, Section 2 aforesaid, and Reserve 325; excepting thereout portion of Church Road and another public road intersecting the above-described area.

SIXTH SCHEDULE

PICTON PRISON

ALL that area in the Marlborough Land District containing 2 acres 1 rood 19:38 perches, more or less, situated in the Borough of Picton, being parts of Sections 483 and 1155, Town of Picton, and part of the old bed of the Waitohi Stream. (S.O. Plan 3926.)

Also all that area in the Marlborough Land District containing 14 perches, more or less, situated in the Borough of Picton, being Lot 2, D.P. 1453, and being part of Sections 336 and 337 and part of the old bed of the Waitohi Stream, Town of Picton.

SEVENTH SCHEDULE

TONGARIRO PRISON FARM

ALL that area in the Wellington Land District containing 14,648 acres and 2 roods, more or less, situated in Blocks X and XI, Puketi Survey District, Block II, Omoho Survey District, Blocks III, IV, and VIII, Pihanga Survey District, and Blocks I, II, V, and VI, Waiotaka Survey District, bounded by a line commencing at a point being the north-eastern corner of Hautu 4B 2B 1 Block and proceeding in an easterly direction along the southern side of the Taupo-Tokaanu Road to the left bank of the Waiotaka River; thence southerly along the left bank of the said river to a point opposite the north-western boundary of Section 3, Block XI, Puketi Survey District; thence easterly generally across the said river to and along the north-western and north-eastern boundaries of Section 3 aforesaid and the southeastern boundary of Section 4, Block XI, Puketi Survey District, to the eastern corner of the last-mentioned section; thence south-easterly along the south-western boundary of Hautu 1B 1B 2A Block to the northernmost corner of Hautu 2B 1B 2D Block; thence westerly and southerly generally along the north-western and south-western boundaries of Hautu 2B 1B 2D Block and the south-western boundary of part of Hautu 2B 1B 2E Block to the southern corner of the last-mentioned block; thence south-westerly along the south-eastern boundary of the southern portion of Hautu 2B 1B 1 Block to the southernmost corner of that block; thence by a right line bearing approximately 242° crossing the Waiotaka River to the eastern corner of Hautu 4B 2B 2B 2 Block; thence north-westerly along the north-eastern boundary of the lastmentioned block and the eastern and northern boundaries of Hautu 4B 2B 2B 1 Block to the right bank of the Tongariro River; thence northerly generally along the right bank of the said river to the southeastern side of the National Park - Taupo State Highway; thence along the south-eastern side of the said highway to the south-western corner of the Town of Taupahi Extension No. 2; thence north-easterly along the south-eastern boundaries of the said town to the western boundary of Hautu 4B 2B 1 Block; thence easterly and northerly generally along the western, southern, and north-eastern boundaries of Hautu 4B 2B 1 Block to the north-eastern corner of the said block, the point of commencement, and excluding therefrom all public roads and the bed of the Waiotaka River, but subject to a Proclamation made under the provisions of section 14 of the Maori Land Amendment and Maori Land Claims Adjustment Act 1926 and published in New Zealand

Gazette 1926, at page 2895, as amended by Proclamations published in New Zealand Gazette 1927, at page 500, and New Zealand Gazette 1952, at page 2037, reserving rights of way to holders of special licences.

Also all that area in the Wellington Land District containing 9,237 acres, more or less, situated in Blocks IV, VII, VIII, X, XI, XII, and XV, Pihanga Survey District, bounded by a line commencing at a point being the intersection of the right bank of the Poutu Stream with the left bank of the Tongariro River, being also the northernmost point of Rangipo North 2B Block, and proceeding south-easterly generally along the left bank of the Tongariro River to the Whitikau Stream; thence by a right line across the Tongariro River to and along the left bank of the Whitikau Stream to the Omarangai Stream; thence by a right line across the Whitikau Stream to and along the left bank of the Omarangai Stream to the north-western side of Hautu Road; thence south-westerly along the north-western side of the said road to the left bank of the Whitikau Stream; thence southerly along the left bank of that stream to the north-western boundary of Hautu 5B 2B 2 Block; thence south-westerly along the said north-western boundary to a point in line with the northern boundary of Rangipo North 2D 2 Block; thence westerly along a right line to and along that northern boundary, the northern boundary of Rangipo North 2D 3 Block, and the production of the last-mentioned boundary to the western side of the Waiouru-Turangi State Highway; thence southerly generally along the western side of the said highway to a point in line with the southern boundary of Rangipo North 3c Block; thence north-westerly along a right line to the southern corner of Rangipo North 2c 1 Block; thence north-easterly along the south-eastern boundaries of Rangipo North 2c 1 and 2c 2 Blocks and across the National Park - Taupo State Highway and again along the south-eastern boundary of Rangipo North 2c 2 Block to the right bank of the Poutu Stream; thence northerly generally along the right bank of the said stream to its intersection with the left bank of the Tongariro River, the point of commencement, and excluding therefrom all public roads, but subject to a Proclamation made under the provisions of section 14 of the Maori Land Amendment and Maori Land Claims Adjustment Act 1926 and published in New Zealand Gazette 1926, at page 2895, as amended by Proclamations published in New Zealand Gazette 1927, at page 500, and New Zealand Gazette 1952, at page 2037, reserving rights of way to holders of special licences.

EIGHTH SCHEDULE

Wanganui Prison

ALL that area in the Wellington Land District containing 3 acres 3 roods and 20 perches, more or less, situated in Block V, Westmere Survey District, being Section 539, Town of Wanganui, formerly described as Section 28, Borough of Wanganui. (S.O. Plan 16847.)
