# THE PENAL INSTITUTIONS NOTICE 1963

Pursuant to the Penal Institutions Act 1954, the Minister of Justice hereby gives the following notice.

### NOTICE

1. This notice may be cited as the Penal Institutions Notice 1963.

### Part I

### Dunedin Prison

2. (1) The portions hereafter described in this subclause of the building in Lower High Street, Dunedin, situated on part of Reserve 3 and part of Section 37, Block XV, Town of Dunedin, and known as the Central Police Station and Prison, are hereby declared to be a prison and a borstal institution to be known as the Dunedin Prison. The said portions comprise:

(a) That portion of the ground floor of the said building shown on the plan marked J. 5/3/1 (Ground Floor Plan), deposited in the Head Office of the Department of Justice, Wellington, and

thereon bordered red;

(b) That portion of the first floor of the said building shown on the plan marked J. 5/3/1 (First Floor Plan), deposited as aforesaid, and thereon bordered red; and

(c) That portion of the second floor of the said building shown on the plan marked J. 5/3/1 (Second Floor Plan) deposited as

aforesaid, and thereon bordered red.

- (2) The remainder of the said building is hereby declared to be a police jail.
- (3) Clause 3 of the Penal Institutions Notice 1955,\* the Second Schedule to that notice, and the Penal Institutions Notice (No. 2) 1959† are hereby revoked.

#### PART II

## Waikeria Youth Centre

3. The areas of land described in the Schedule hereto, being areas intended to be used for prerelease hostels at Mount Albert and Hamilton, are hereby added to and declared parts of the borstal institution known as the Waikeria Youth Centre‡.

### Prerelease Hostel: Mt. Albert

ALL that area in the North Auckland Land District containing 24.9 perches, more or less, being part of Allotment 39, Parish of Titirangi, and being all the land comprised in certificate of title, Volume 1104, folio 214 (limited as to parcels), Auckland Registry: as the same is delineated on the plan marked J. 5/3/13 Prerelease Hostel, Mt. Albert, deposited in the Head Office of the Department of Justice, Wellington, and thereon bordered blue.

Also all that area in the North Auckland Land District, being Lots 53 and 56 and part of Lots 54, 55, and 57, Deeds Plan 28, being part of Allotment 39, Parish of Titirangi, and being part of the land comprised in certificate of title, Volume 536, folio 237 (limited as to parcels), Auckland Registry: as the same is delineated on the aforesaid plan and

thereon bordered vellow.

# Prerelease Hostel: Hamilton

All that area in the South Auckland Land District containing 36.04 perches, more or less, being part of Lot 3, Deposited Plan 14168, being part of Allotments 1 and 1A, Parish of Te Rapa, and being the residue of the land comprised in certificate of title, Volume 373, folio 236, Hamilton Registry:

Also all that area in the South Auckland Land District containing 1.28 perches, more or less, being part of Lot 2, Deposited Plan 14168, being part of Allotments 1 and 1A, Parish of Te Rapa, and being all the land comprised in certificate of title, Volume 636, folio 21, Hamilton

Registry.
