THE PENAL INSTITUTIONS NOTICE 1971

PURSUANT to the Penal Institutions Act 1954, the Minister of Justice hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Penal Institutions Notice 1971.

(2) This notice shall take effect from the 30th day of June 1971.

2. Land excluded from Tongariro Prison Farm and Tongariro Detention Centre—The land described in the First Schedule hereto is hereby declared to be excluded from—

- (a) The prison known as the Tongariro Prison Farm*[†]; and
- (b) The detention centre known as the Tongariro Detention Centre[†].

3. Land added to Tongariro Prison Farm and Tongariro Detention Centre—The land described in the Second Schedule hereto is hereby declared to be added to—

- (a) The prison known as the Tongariro Prison Farm*[†]; and
- (b) The detention centre known as the Tongariro Detention Centre[†].

LAND EXCLUDED FROM TONGARIRO PRISON FARM AND TONGARIRO DETENTION CENTRE

ALL that piece of land in the Wellington Land District and the County of Taupo containing 735 acres, more or less, being part Hautu 2B1B1, situated in Block II, Omoho Survey District, Block I, Waiotaka Survey District, and Block XI, Puketiki Survey District; as the same is more particularly shown on plan marked M.L. 5196, held in the District Office of the Department of Lands and Survey at Wellington, and thereon edged red.
