THE PENAL INSTITUTIONS NOTICE 1974

PURSUANT to the Penal Institutions Act 1954 and the Criminal Justice Act 1954, but so far only in the case of the last-mentioned Act as the authority of that Act is necessary for the revocation effected by sub-clause (3) of clause 4 of this notice, the Minister of Justice hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Penal Institutions Notice 1974.

(2) This notice shall take effect from the 8th day of August 1974.

2. Dunedin Prison—(1) The portions hereafter described in this sub-clause of the building in Lower High Street, Dunedin, situated on part of Reserve 3 and part of Section 37, Block XV, Town of Dunedin, and known as the Central Police Station and Prison, are hereby declared to be a prison to be known as the Dunedin Prison. The said portions comprise:

- (a) That portion of the ground floor of the said building shown on the plan marked J. 5/3/1 (Ground Floor Plan) and dated 1 July 1974, deposited in the Head Office of the Department of Justice, Wellington, and thereon bordered red; and
- (b) That portion of the first floor of the said building shown on the plan marked J. 5/3/1 (First Floor Plan) and dated 1 July 1974, deposited as aforesaid and thereon bordered red; and
- (c) That portion of the second floor of the said building shown on the plan marked J. 5/3/1 (Second Floor Plan) and dated 1 July 1974, deposited as aforesaid, and thereon bordered red.

(2) The remainder of the said building is hereby declared to be a police jail.

(3) Part I of the Penal Institutions Notice 1963* is hereby revoked.

3. Land excluded from Waikeria Youth Centre—(1) The land described in the First Schedule hereto, comprising the premises of the pre-release hostel at Mount Albert, is hereby declared to be excluded from the borstal institution known as the Waikeria Youth Centre†.

(2) The Penal Institutions Notice 1963*, is hereby consequentially amended by revoking so much of the Schedule as relates to the Prerelease Hostel: Mt. Albert.

4. Land added to Mount Eden Prison—(1) The land described in the First Schedule hereto, comprising the premises of the prerelease hostel at Mount Albert, is hereby declared to be added to the prison known as Mount Eden Prison*.

(2) The land described in the Second Schedule hereto is hereby declared to be added to the prison known as Mount Eden Prison*.

(3) The Work Centre Notice 1967† is hereby revoked.

5. Land added to Tongariro Prison Farm—The land described in the Third Schedule hereto is hereby declared to be added to the prison known as the Tongariro Prison Farm‡.

6. Land added to Wellington Prison—(1) The land described in the Fourth Schedule hereto is hereby declared to be added to the prison known as Wellington Prison§.

(2) The land described in the Fourth Schedule hereto is hereby declared to be excluded from both the prison known as the Arohata Prison|| and the borstal institution known as the Arohata Borstal Institution||.

(3) The Penal Institutions Notice 1968¶ is hereby amended by revoking clause 2 and the First Schedule.

FIRST SCHEDULE

Prerelease Hostel: Mt. Albert

ALL that piece of land in the North Auckland Land District containing 24.9 perches, more or less, being part of Allotment 39, Parish of Titirangi, and being all the land comprised in certificate of title, Volume 1104, folio 214 (limited as to parcels), Auckland Registry: as the same is delineated on the plan marked J. 5/3/13 Prerelease Hostel, Mount Albert, deposited in the Head Office of the Department of Justice, Wellington, and thereon bordered blue.

Also all those pieces of land in the North Auckland Land District, being Lots 53 and 56 and part of Lots 54, 55, and 57, Deeds Plan 28, being part of Allotment 39, Parish of Titirangi, and being part of the land comprised in certificate of title, Volume 536, folio 237 (limited as to parcels), Auckland Registry: as the same is delineated on the aforesaid plan and thereon bordered yellow.

SECOND SCHEDULE

Addition to Mount Eden Prison

ALL that piece of land in the Borough of Mount Eden containing 30 perches, more or less, and being part Allotment 105, Section 6, suburbs of Auckland, situated in Block VIII, Rangitoto Survey District, and being the land shown coloured yellow on S.O. plan 45373.

THIRD SCHEDULE

Additions to Tongariro Prison Farm

1. All those pieces of land in the Wellington Land District containing together 7 acres and 24 perches, more or less, situated in Block XI, Pihanga Survey District, being formerly parts of Rangipo North 3c and being now closed road; as the said pieces of land are more particularly delineated on S.O. Plan 27963, and thereon coloured blue and edged blue.

(2) All that piece of land containing 3.8270 hectares, more or less, being part of Block XI, Pihanga Survey District (S.O. 27050), as the same is more particularly delineated as section 1 on a plan marked J. 5/3/4, held in the Head Office of the Department of Justice, and thereon edged in red.

3. All that piece of land containing 1.1751 hectares, more or less, being part of Block XI, Pihanga Survey District (S.O. 27050), as the same is more particularly delineated as section 2 on a plan marked J. 5/3/4, held in the Head Office of the Department of Justice, and thereon edged in red.

4. All that piece of land containing 8.2019 hectares, more or less, being part of Block VII, Pihanga Survey District (S.O. 26967), as the same is more particularly delineated as section 3 on a plan marked J. 5/3/4, held in the Head Office of the Department of Justice, and thereon edged in red.

FOURTH SCHEDULE

Addition to Wellington Prison

ALL that piece of land in the City of Wellington containing 11.9 perches, more or less, being part Section 96, Town of Wellington, and being part of the land in A Plan 3120, and being all the land comprised and described in certificate of title, Volume 126, folio 88, Wellington Registry.
