

THE PENAL INSTITUTIONS NOTICE 1984

PURSUANT to section 4 of the Penal Institutions Act 1954, the Minister of Justice hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Penal Institutions Notice 1984.
 - (2) This notice shall take effect from the 1st day of May 1984.
- 2. New Plymouth Prison—The land first described in the Schedule to this notice, which is declared by clause 5 of the Penal Institutions Notice 1955* to be a prison to be known as the New Plymouth Prison, is hereby declared to be also a youth prison.
- **8. Wi Tako Prison**—The land secondly described in the Schedule to this notice, which was declared by clause 2 of the Penal Institutions Notice 1956† to be a prison to be known as the Wi Tako Prison and by clause 2 of the Penal Institutions Notice 1957‡ to be also a borstal institution to be known as the Wi Tako Borstal Institution, is hereby declared to be—
 - (a) No longer a borstal institution; and
 - (b) Also a youth prison.
- **4. Dunedin Prison**—The parts of the building thirdly described in the Schedule to this notice, which were declared by clause 2 (1) of the Penal Institutions Notice 1974§ to be a prison to be known as the Dunedin Prison, are hereby declared to be also a youth prison.
 - 5. Revocation—The Penal Institutions Notice 1957‡ is hereby revoked.

SCHEDULE

NEW PLYMOUTH PRISON

All that parcel of land in the Taranaki Land District, containing 12 acres 1 rood and 33 perches, more or less, being Section 2344 and part Section 2343, Town of New Plymouth.

SCHEDULE—continued

Also all that parcel of land in the Taranaki Land District, containing 6 acres 1 rood and 3 perches, more or less, being Section 2345, Town of New Plymouth, and part Section W, New Plymouth Town Belt, and being Lot 1 on Deposited Plan 1775, and Lot 2A on Deposited Plan 1843.

As the same are more particularly delineated on the plan marked J. 7/6/deposited in the Head Office of the Department of Justice, Wellington, and thereon edged red. (S.O. Plans 1072 and 3263.)

WI TAKO PRISON

All that parcel of land in the Wellington Land District, containing 583 acres 2 roods and 8.1 perches, more or less, situated in the Hutt County, being part Sections 100, 104, 105, 106, 108, and 206, Hutt District, Block I, Rimutaka Survey District, and being part of the land comprised and described in certificate of title, Volume 57, folio 4, Wellington Registry. (S.O. Plans 17258 and 22625.)

Also all that parcel of land in the Wellington Land District, containing 300 acres, more or less, situated in the Hutt County, being part Sections 104, 106, 107, 108, 109A, and 285, Hutt District, Block I, Rimutaka Survey District, and being part of the land comprised and described in certificate of title, Volume 57, folio 4, Wellington Registry; as the same is more particularly delineated on a plan marked J. 7/13/6 deposited in the Head Office of the Department of Justice, Wellington, and thereon edged red.

DUNEDIN PRISON

All those parts, specified in paragraphs (a) to (c) of this description, of the building in Lower High Street, Dunedin, situated on part of Reserve 3 and part of Section 37, Block XV, Town of Dunedin, being known as the Central Police Station, and Prison:

(a) That part of the ground floor of the building shown on the plan marked J. 5/3/1 (Ground Floor Plan) and dated 1 July 1974, deposited in the Head Office of the Department of Justice, Wellington, and thereon edged red:

(b) That part of the first floor of the building shown on the plan marked J. 5/3/1 (First Floor Plan) and dated 1 July 1974, deposited in the Head Office of the Department of Justice, Wellington, and thereon edged red:

(c) That part of the second floor of the building shown on the plan marked J. 5/3/1 (Second Floor Plan) and dated 1 July 1974, deposited in the Head Office of the Department of Justice, Wellington, and thereon edged red.
