

THE PENAL INSTITUTIONS NOTICE 1995

PURSUANT to section 4 of the Penal Institutions Act 1954, the Minister of Justice hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Penal Institutions Notice 1995.
 - (2) This notice shall take effect from the 11th day of May 1995.
- 2. Wanganui Prison at Kaitoke—The land described in the First Schedule to this notice (being part of the land presently known as the Wanganui Prison at Kaitoke) is hereby declared to be a prison, to be known as the Wanganui Prison at Kaitoke.
- **3. Establishment of Police jail**—The building and land described in the Second Schedule to this notice are hereby declared to be a Police jail.
 - **4. Revocations**—The following notices are hereby revoked:
 - (a) The Penal Institutions Notice (No. 3) 1976*:
 - (b) The Penal Institutions Notice (No. 2) 1978†.

FIRST SCHEDULE

C1. 2

All that parcel of land in the Wellington Land District, containing 191.3277 hectares, more or less, being Section 1, Block X, Ikitara Survey District (S.O. Plan 19401); and

All that parcel of land in the Wellington Land District, containing 122.8448 hectares, more or less, being the Balance of Section 2, Block IX, Ikitara Survey District, after excluding Section 518, Left Bank Wanganui River (S.O. Plans 19401 and 27717); and

All that parcel of land in the Wellington Land District, containing 31.2855 hectares, more or less, situated in Block X, Ikitara Survey District, being Sections 478, 479, and 480, Left Bank Wanganui River (S.O. Plan 25322), excluding the building and land described in the Second Schedule to this notice; and

All that parcel of land in the Wellington Land District, containing 56.7040 hectares, more or less, situated in Block IX, Ikitara Survey District, being Section 516, Left Bank Wanganui River (S.O. Plan 27717); and

All that parcel of land in the Wellington Land District, containing 0.2964 hectares, more or less, situated in Block X, Ikitara Survey District, being Section 514, Left Bank Wanganui River (S.O. Plan 27782); and

All that parcel of land in the Wellington Land District, containing 11.42 hectares, more or less, being part Section 108 and part Lots 1 and 2 on Deposited Plan 10028, and being part of the land comprised and described in certificates of title, Volume 13C, folio 746 and Volume 432, folio 102, Wellington Registry; as the same is more particularly delineated on the plan marked Adm. 13-7-91-1 Pt. 2 held in the Head Office, Department of Justice, and thereon coloured red.

SECOND SCHEDULE

The building and land shown on the plan marked LRD 28-5, Part 2, and dated 1 May 1995, held in the Head Office of the Department of Justice, Wellington and thereon coloured red; which building is situated on, and which land is part of, that parcel of land in the Wellington Land District, containing 31.2855 hectares, more or less, situated in Block X, Ikitara Survey District, being Sections 478, 479, and 480, Left Bank Wanganui River (S.O. Plan 25822).

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, made pursuant to the Penal Institutions Act 1954,-

(a) Declares the land set out in the First Schedule to the notice (being part of the land presently known as the Wanganui Prison at Kaitoke) to be a prison, to be known as the Wanganui Prison at Kaitoke; and

(b) Declares the building and land described in the Second Schedule to the notice to be a Police jail.
