

## **PENAL INSTITUTIONS NOTICE 1997**

PURSUANT to the Penal Institutions Act 1954, the Minister of Corrections gives the following notice.

#### **NOTICE**

- 1. Title and commencement—(1) This notice may be cited as the Penal Institutions Notice 1997.
  - (2) This notice takes effect from 2 October 1997.
- **2. Parts of buildings added to Mount Eden Prison**—The parts of the buildings described in Schedule 1 are declared to be added to the prison known as Mount Eden Prison\*.
- **3. Parts of buildings added to Rimutaka Prison**—The parts of the buildings described in Schedule 2 are declared to be added to the prison known as Rimutaka Prison†.
- **4. Parts of building added to Christchurch Prison**—The parts of the building described in Schedule 3 are declared to be added to the prison known as Christchurch Prison‡.

## Cl. 2 SCHEDULE 1

PARTS OF BUILDINGS ADDED TO MOUNT EDEN PRISON

The cell block contained within the building complex known as the Auckland High Court situated on all that parcel of land in the North Auckland Land District containing 6188 square metres, more or less, being Allotment 12 Section 2 City of Auckland and Allotment 13 Section 12 City of Auckland, and being all the land comprised and described in certificate of title No. 88C/879, North Auckland Registry; and

The cell block contained within the building complex known as the Auckland District Court situated on all that parcel of land in the North Auckland Land District containing 3232 square metres, more or less, being Lot 1 Deposited Plan 107968 and being part Allotments 11, 12, 13, 14 and 15 Section 21 City of Auckland, and being all the land comprised and described in certificate of title No. 60A/1051, North Auckland Registry.

PARTS OF BUILDINGS ADDED TO RIMUTAKA PRISON

The cell block contained within the building complex known as the Wellington High Court situated on—

- (b) All that parcel of land in the Wellington Land District containing 989 square metres, more or less, situate in the City of Wellington, being Section 2 on Survey Office Plan 35741, and being all the land comprised and described in certificate of title No. 43B/186, Wellington Registry; and

The cell block contained within the building complex known as the Wellington District Court situated on all that parcel of land in the Wellington Land District containing 1641 square metres, more or less, situate in the City of Wellington being Sections 1, 2 and 3 Block VI Thorndon Reclamation and Lot 1 on Deposited Plan 6634, and being all the land comprised and described in certificate of title No. 41D/189, Wellington Registry.

PARTS OF BUILDING ADDED TO CHRISTCHURCH PRISON

The cell blocks contained within the building complex known as the Christchurch Courthouse, containing the High Court and District Court, situated on—

- (a) All that parcel of land in the Canterbury Land District containing 4426 square metres, or thereabouts, being Section 1182 Town of Christchurch, and being all the land comprised and described in certificate of title No. 36A/523, Canterbury Registry; and
- (b) All that parcel of land in the Canterbury Land District containing 5078 square metres, or thereabouts, being Section 1 Survey Office Plan 11619, and being all the land comprised and described in certificate of title No. 36B/317, Canterbury Registry.

- (c) Declares the cell blocks at the Christchurch Courthouse (containing the High Court and the District Court) to be part of Christchurch Prison.
