## THE PENAL INSTITUTIONS NOTICE (NO. 2) 1958

PURSUANT to the Penal Institutions Act 1954, the Minister of Justice hereby gives the following notice.

### NOTICE

1. This notice may be cited as the Penal Institutions Notice (No. 2) 1958.

#### PART I

2. The land described in the First Schedule hereto is hereby declared to be a borstal institution, known as the Invercargill Borstal Institution; and also to be a prison, known as the Invercargill Prison.

3. The land described in the Second Schedule hereto is hereby declared to be a prison, known as the Waikune Prison.

4. The land described in the Third Schedule hereto is hereby declared to be a prison, known as the Rolleston Prison.

5. This Part of this notice is in substitution for the Proclamations and notice which relate to the said penal institutions and which are specified in the Fourth Schedule hereto, and the said notice is hereby revoked.

#### PART II

6. It is hereby declared that the prison known as the Picton Prison shall hereafter cease to be a prison and accordingly clause 7 and the Sixth Schedule of the Penal Institutions Notice 1955 are hereby revoked.

7. It is hereby declared that the police jails situated at the following places, namely, Dargaville, Kaeo, Rawene, Russell, Ruatoria, Kawhia, Raglan, Coromandel, Raetihi, and Kaikoura shall hereafter cease to be police jails.

### SCHEDULES

#### FIRST SCHEDULE

##### INVERCARGILL BORSTAL INSTITUTION AND INVERCARGILL PRISON

ALL that area in the Southland Land District containing 140 acres 1 rood, more or less, being Lots 4, 5, 6, 7, 10, and part of Lot 9, D.P. 3030, being part of Section 19, Block XXI, Invercargill Hundred.

Also all that area in the Southland Land District containing 330 acres 2 roods 37·4 perches, more or less, being Lots 4, 5, 10, and 13, being part of Section 19, Block XXI, Invercargill Hundred (S.O. Plan 4611).

FIRST SCHEDULE—*continued*

Also all that area in the Southland Land District containing 11 acres 24·7 perches, more or less, being Section 43 and Lot 2 and part of Lot 1, Block VI, D.P. 299, being part of Section 27, Block I, Invercargill Hundred (S.O. Plan 6191).

Also all that area in the Southland Land District containing 651 acres 3 roods 16 perches, more or less, being Lot 7, being part of Section 19, Block XXI, Invercargill Hundred (S.O. Plan 4611).

Also all that area in the Southland Land District containing 71 acres 1 rood, more or less, being parts of Sections 15 and 15A, Block XXI, Invercargill Hundred (S.O. Plan 4679).

Also all that area in the Southland Land District containing 417 acres 2 roods 24 perches, more or less, being Sections 19–28 and 56 and parts of Sections 53–55, Block XX, Invercargill Hundred (S.O. Plan 5599).

As the same are delineated on plans numbered 1 to 6 in the sequence described as J. 5/3/2, deposited in the Head Office of the Department of Justice, Wellington, and thereon bordered red.

## SECOND SCHEDULE

## WAIKUNE PRISON

ALL that area in the Wellington Land District containing 108 acres 1 rood 13 perches, more or less, being parts of Waimarino 4A No. 5 Block, situated in Block IV, Manganui Survey District (coloured red on S.O. Plan 20332).

Also all that area in the Wellington Land District containing 2 roods 33·3 perches, more or less, being closed road adjoining or passing through part Waimarino 4A No. 5 Block situated in Block IV, Manganui Survey District (coloured yellow on S.O. Plan 20332).

Also all that area in the Wellington Land District containing 2 acres 3 roods 25 perches, more or less, being Section 2, Block IV, Manganui Survey District (S.O. Plan 19419).

Also all that area in the Wellington Land District containing 1 acre 2 roods, more or less, being Section 3, Block IV, Manganui Survey District (S.O. Plan 19419).

Also all that area in the Wellington Land District containing 3 acres 3 roods, more or less, being Section 4, Block IV, Manganui Survey District (S.O. Plan 19419).

Also all that area in the Wellington Land District containing 13 acres, more or less, being Section 5, Block IV, Manganui Survey District (S.O. Plan 19419).

As the same are delineated on the plan marked J. 5/3/16/1958, deposited in the Head Office of the Department of Justice, Wellington, and thereon hatched red.

## THIRD SCHEDULE

## ROLLESTON PRISON

ALL that area in the Canterbury Land District containing 5 acres 19·6 perches, more or less, being part of Reserve 1636 situated in Block II, Leeston Survey District, as the same is delineated on the plan marked J. 5/3/21, deposited in the Head Office of the Department of Justice, Wellington, and thereon bordered red (S.O. Plan 9396).
