THE PENAL INSTITUTIONS NOTICE (NO. 2) 1981

PURSUANT to section 4 of the Penal Institutions Act 1954, the Minister of Justice hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Penal Institutions Notice (No. 2) 1981.

(2) This notice shall take effect from the 9th day of April 1981.

2. Arohata Youth Institution—The land described in the First Schedule to this notice, which is declared by clause 2 of the Penal Institutions Notice 1955* to be a borstal institution and a prison, is hereby declared to be also a youth prison and a corrective training institution, the whole establishment to be henceforth known as the Arohata Youth Institution.

3. Invercargill Youth Institution—The land described in the Second Schedule to this notice, which is declared by clause 2 of the Penal Institutions Notice (No. 2) 1958[†] (as amended from time to time) to be a borstal institution and a prison, is hereby declared to be also a youth prison, the whole establishment to be henceforth known as the Invercargill Youth Institution.

4. Manawatu Youth Institution—The land described in the Third Schedule to this notice, which is declared by clause 2 of the Penal Institutions Notice (No. 3) 1978⁺ to be a borstal institution and a prison, is hereby declared to be also a youth prison.

5. Rangipo Prison Farm—The land described in the Fourth Schedule to this notice, which is declared by clause 3 of the Penal Institutions Notice (No. 4) 1978§ to be a prison, is hereby declared to be also a corrective training institution.

6. Rolleston Prison—(1) The land described in the Fifth Schedule to this notice, which is declared by clause 2 of the Penal Institutions Notice (No. 3) 1959* (as amended) and by clause 2 of the Penal Institutions Notice (No. 2) 1972† to be part of the prison known as the Christchurch Prison and part of the borstal institution known as the Christchurch Borstal Institution, is hereby declared to be also a prison and a corrective training institution, to be known as the Rolleston Prison.

(2) The land described in the Fifth Schedule to this notice is hereby declared to be excluded from the prison known as the Christchurch Prison.

(3) Clauses 2 (a) and 3 of the Penal Institutions Notice (No. 2) 1972^{+} are hereby revoked.

7. Tongariro Prison Farm—The land described in the Sixth Schedule to this notice, which is declared by clause 2 of the Penal Institutions Notice (No. 4) 1978⁺ to be a prison, is hereby declared to be also a corrective training institution.

8. Waikeria Youth Institution—(1) The land described in the Seventh Schedule to this notice, which is declared by clause 2 of the Penal Institutions Notice 1961[§] to be a prison and a borstal institution, is hereby declared to be also a youth prison, the whole establishment to be henceforth known as the Waikeria Youth Institution.

(2) Clause 2 (c) of the Penal Institutions Notice 1961 is hereby revoked.

9. Auckland Maximum Security Prison—The land described in the Eighth Schedule to this notice is hereby declared to be a prison, to be known as the Auckland Maximum Security Prison.

10. Auckland Medium Security Prison—The land described in the Ninth Schedule to this notice is hereby declared to be a prison, to be known as the Auckland Medium Security Prison.

11. Revocation—Clause 2 of the Penal Institutions Notice (No. 3) 1968 and the First Schedule to that notice are hereby revoked.

ALL that area in the Wellington Land District containing 3825 hectares, more or less, bounded by a line commencing at a point being the intersection of the right bank of the Poutu River with the left bank of the Tongariro River, being also the northernmost point of Rangipo North 2B, in Block IV Pihanga Survey District and proceeding generally southeasterly along the left bank of the Tongariro River to a point due west of the left bank of the Whitikau Stream; thence along a right line across the Tongariro River to and generally south-easterly along the left bank of the Whitikau Stream to a point due west of the left bank of the Omarangai Stream; thence along a right line across the Whitikau Stream to and along the left bank of the Omarangai Stream to the north-western side of Hautu Road; thence south-westerly along the north-western side of that road to the left bank of the Whitikau Stream; thence generally southerly along the left bank of that stream to the north-western boundary of Hautu 5B2B2A in Block XII Pihanga Survey District; thence south-westerly along that north-western boundary to the southern boundary of Hautu 5B2A; thence westerly along that boundary and its production to the northern boundary of Rangipo North 2D2; thence westerly along that northern boundary the northern boundary of Rangipo North 2D3 and the production of the lastmentioned boundary to the western side of No. 1 State Highway; thence generally southerly along the western side of that highway to a point in line with the southern boundary of Rangipo North 3C in Block XV Pihanga Survey District; thence north-westerly along a right line to the southern corner of Rangipo North 2C1 in Block X Pihanga Survey District; thence north-easterly along the south-eastern boundaries of Rangipo North 2C1 and 2C2 across No. 47 State Highway and again along the south-eastern boundary of Rangipo North 2C2 to the right bank of the Poutu River in Block VII Pihanga Survey District; thence generally north-easterly along the right bank of the said stream to its intersection with the left bank of the Tongariro River, the point of commencement, as the same is more particularly delineated on the plan marked LEG 28.2.1 held in the Head Office, Department of Justice, and thereon coloured green.

ALL that area in the Wellington Land District containing 5487 hectares, more or less, bounded by a line commencing at the north-eastern corner of Hautu 4B2B1 in Block XI Puketi Survey District and proceeding generally easterly along the southern side of Waiotaka Road to the left bank of the Waitoka River; thence generally south-easterly along the left bank of the said river to a point in line with the north-western boundary of Section 3, Block XI, Puketi Survey District; thence generally northeasterly to and along that north-western boundary and south-easterly along the north-eastern boundary of Section 3 aforesaid to the northern boundary of Hautu 2B1B1; thence north-easterly, generally south-easterly and south-westerly along the north-western, generally north-eastern and south-eastern boundaries of Hautu 2B1B1 to the westernmost point of Hautu A in Block I Waiotaka Survey District; thence south-easterly and north-easterly along the south-western and south-eastern boundaries of the last-mentioned block to the south-western boundary of Hautu 2B1B2D2; thence south-easterly along that boundary and the southwestern boundary of Hautu 2B1B2E to the generally north-western boundary of the Kaimanawa State Forest Park as described in New Zealand Gazette 1969 page 1885; thence generally south-westerly along that north-western boundary to the easternmost corner of Hautu 4B2B2B2F2 in Block V Waiotaka Survey District; thence south-easterly and generally south-westerly along the north-eastern and south-eastern boundaries of the aforesaid block to the westernmost corner of Hautu 4B2B2B2F1; thence south-easterly along the north-eastern boundaries of Hautu 4B2A2D and 4B2A2C2 to the south-eastern corner of the last-mentioned block; thence generally westerly along the northern boundaries of Hautu 4B2A2C1 and 4B2A2B1 and generally westerly and northerly along the northern and eastern boundaries of Hautu 5B2B2A and the production of the last-mentioned boundary to the middle of the Whitikau Stream in Block VIII, Pihanga Survey District; thence generally northerly down the middle of that stream to a point in line with the north-western side of Hautu Road; thence to and along the north-western side of the said Road to the north-eastern side of Tongariro Road; thence north-westerly along
