



THE PENAL INSTITUTIONS NOTICE (NO. 3) 1968

PURSUANT to the Penal Institutions Act 1954, the Minister of Justice hereby gives the following notice.

NOTICE

1. **Title**—This notice may be cited as the Penal Institutions Notice (No. 3) 1968.

2. **Auckland Prison**—The land described in the First Schedule hereto is hereby declared to be a prison to be known as Auckland Prison.

3. **Mount Eden Prison**—(1) The land described in the Second Schedule hereto is hereby declared to be a prison to be known as Mount Eden Prison.

(2) Subclause (1) of this clause is in substitution for the Proclamation\* of the 30th day of July 1856 by which a building at Mount Eden was declared and proclaimed a public gaol by the Superintendent of the Province of Auckland and for the Penal Institutions Notice (No. 2) 1968†.

(3) The Penal Institutions Notice (No. 2) 1968 is hereby revoked.

FIRST SCHEDULE

AUCKLAND PRISON

ALL those pieces of land situated in Block VI, Waitemata Survey District, North Auckland Land District, described as follows—

## SECOND SCHEDULE

## MOUNT EDEN PRISON

FIRST, all that piece of land containing 35 acres 2 roods 22.6 perches, more or less, being Allotment 154 and part Allotments 105, 106, 107, 108, and 109 of Section 6, Suburbs of Auckland, situated in Block XVI, Waitemata Survey District, and Block VIII, Rangitoto Survey District.

Secondly, all that piece of land containing 1 rood 24.5 perches, more or less, being part Allotment 73, Section 10, Suburbs of Auckland, and being the whole of the land comprised and described in certificate of title, Volume 578, folio 289, North Auckland Land Registry (limited as to parcels).
