### **Notice**

#### 1 Title

This notice is the Penal Institutions (Ohura Prison) Notice 2003.

#### 2 Commencement

This notice takes effect from 7 August 2003.

#### 3 Ohura Prison

The land described in the Schedule is declared to be a prison, to be known as Ohura Prison.

#### 4 Revocation

The Penal Institutions (Ohura Prison) Notice 1998 (SR 1998/119) is revoked.

The notice replaces the legal description of the land that makes up Ohura Prison. The updated description excludes 1 parcel of land containing 1222 square metres from the prison land.
