THE POSITIVE LIST OF CONTROLLED GOODS AND SERVICES 1977

PURSUANT to section 82 of the Commerce Act 1975, the Minister of Trade and Industry,—

- (a) Being of the opinion that the making of this notice is required for the purpose of effecting the consolidation of existing amendments to the Positive List of Controlled Goods and Services and of correcting an error therein; and
- (b) After reference to the Commerce Commission in respect of the replacement by metric terms of the Imperial weights and measures formerly specified in that list,—

hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Positive List of Controlled Goods and Services 1977.

(2) This notice shall come into force on the 1st day of January 1978.

2. Controlled goods and services—The goods and services specified in the First Schedule hereto are the goods and services for the time being subject to price control under Part IV of the Commerce Act 1975.

3. Revocations—The notices specified in the Second Schedule hereto are hereby revoked.

Building Materials

Building boards in their primary state of manufacture (including wallboards of the Pinex and Gibraltar Board types, hardboard, and particle boards).

Chemicals and Chemical Substances

Drugs and related commodities:

- Drugs and any other substances and mixtures of substances specially prepared for use in the treatment, prevention, investigation, or alleviation of any disease, illness, or injury included in any drug tariff or amendment issued pursuant to section 99 of the Social Security Act 1964.
- Fertilisers:
 - Inorganic fertilisers and ingredients, and fertiliser mixtures containing inorganic ingredients, except when sold retail in quantities less than 50 kg or of less than 45 litres in the case of liquid fertilisers.
 - Urea, blood and bone, dried blood and bone dust, except when sold retail in quantities less than 50 kg.

Foodstuffs and Related Commodities

Apples and pears sold by retailers.

Bananas sold by retailers.

Bread (except sold as part of a meal and bread sold in Stewart Island).

- Butter, manufactured in New Zealand, excluding butter when sold in portions not exceeding 30 g.
- Canned foods and canned pet foods manufactured by persons whose annual turnover exceeds \$1,000,000 and sold by such persons.
- Cigarettes, excluding cigars and cheroots.

Eggs, hen and duck.

- Flour, including gluten, wheatmeal, and wholemeal, but excluding-(a) Self-raising flour, soya bean, and rye flour; and
 - (b) Wheatmeal and wholemeal in packs of 5 kg or less when sold by retailers and wholesalers other than the New Zealand Wheat Board or its agents.

Oranges, imported, sold by retailers.

Soap, washing powders, and detergents manufactured by persons whose annual turnover exceeds \$1,000,000 and sold by such persons.

- Stock food of the following kinds:
 - Bran and pollard, excluding bran and pollard sold by distributors and retailers.
- Sugar, excluding raw sugar, No. 3 Brown sugar, castor sugar, icing sugar, loaf sugar, and coffee sugar crystals.
- Tobacco, not including raw tobacco as defined in the Tobacco Growing Industry Act 1974.
- Vegetables, dried or frozen, with or without other ingredients, sold by manufacturers whose annual turnover exceeds \$1,000,000.
- Wheat, excluding certified seed wheat and wheat sold for use as stock food by distributors and retailers.

Intoxicating liquor:

All intoxicating liquor sold in public bars of hotels, taverns, or other premises licensed under the Sale of Liquor Act 1962, or deemed to be licensed under that Act pursuant to the Licensing Trusts Act 1949, or the Masterton Licensing Trust Act 1947, or the Invercargill Licensing Trust Act 1950; and

All draught beer in flagons, and bottled beer in bottles containing not less than 745 millilitres, sold for consumption off the premises in hotels, taverns, or other premises licensed under the Sale of Liquor Act 1962, or deemed to be licensed under that Act pursuant to the Licensing Trusts Act 1949, or the Masterton Licensing Trust Act 1947, or the Invercargill Licensing Trust Act 1950.

Beer, manufacturers' and packers' prices. Spirits, manufacturers' and packers' prices.

Hardware

Bolts.

Galvanised iron.

Metals, ferrous and non-ferrous, in ingot, billet, sheet, strip, bar, rod, tube, sectional shapes, and in any other primary or intermediary state, or in alloy forms (including aluminium, brass, copper, iron, steel, lead, zinc, tin, and tinplate), but excluding extruded brass rod.

Metal pipes and pipe fittings, except pipe fittings of brass.

Wire, baling, barbed, fencing and reinforcing, but excluding bare copper and binding.

Vehicles

Motor vehicles of the following kinds, including chassis and cabs. Cars.

Trucks, except "goods service vehicles" as defined in section 2 of the Transport Act 1962, and which have a manufacturer's gross laden weight of 4500 kg or more.

Vans.

Ranch and station wagons.

Services

Charges, fees, rates, or commissions payable in respect of the following: Egg distribution and handling.

Shipping fares and freights.

Wheat broking.

Charges made by freight forwarding companies or persons for the consolidation and conveyance of goods by land, sea, or air, and all charges incidental thereto.

Miscellaneous

Ceramic tableware, ceramic kitchenware, and ceramic household fittings:

Imported.

New Zealand, made by persons whose annual turnover exceeds \$1,000,000.

Cornsacks.

Gas, natural or manufactured, other than sales of natural gas under the Gas Purchase Contract made the 31st day of July 1967 between
