

THE POSITIVE LIST OF CONTROLLED GOODS AND SERVICES 1981

Pursuant to section 82 of the Commerce Act 1975 and to section 12 of the Ministry of Energy Act 1977, the Minister of Trade and Industry and the Minister of Energy hereby give the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Positive List of Controlled Goods and Services 1981.
- (2) This notice shall come into force on the day after the date of its notification in the *Gazette*.
- 2. Controlled goods and services—The goods and services described in the First and Second Schedules hereto are the goods and services for the time being subject to price control under Part IV of the Commerce Act 1975.
- 3. Revocations—The notices specified in the Third Schedule hereto are hereby revoked.

GOODS AND SERVICES CONTROLLED BY THE SECRETARY OF TRADE AND INDUSTRY

Building Materials

- 1. Cement, manufactured in New Zealand, when sold by the manufacturer.
- 2. Sheet window glass, manufactured in New Zealand, when sold by the manufacturer.
 - 3. Timber, New Zealand-grown exotic.
- 4. Timber services which are performed in relation to New Zealandgrown exotic timber or timber imported into New Zealand and which are of the following descriptions:
 - (a) Dressing:
 - (b) Drying, air or kiln:
 - (c) Measuring and gauging:

Chemicals and Chemical Substances

- 5. Blood and bone, dried blood, and bone dust, except when sold at retail in quantities of less than 50 kg.
- 6. Drugs and any other substances and mixtures of substances specially prepared for use in the treatment, prevention, investigation, or alleviation of any disease, illness, or injury included in any drug tariff or amendment issued pursuant to section 99 of the Social Security Act 1964.
- 7. Inorganic fertilisers and fertiliser mixtures containing inorganic ingredients, except when sold at retail in quantities of less than 50 kg or of less than 45 litres in the case of liquids.
 - 8. Urea, except when sold at retail in quantities of less than 50 kg.

Foodstuffs and Related Commodities

- 9. Bananas, when sold by a retailer.
- 10. Bran and pollard, when sold by a miller or by the New Zealand Wheat Board or its agents.
 - 11. Butter, manufactured in New Zealand, except when sold-

(a) Ex factory; or

- (b) In portions not exceeding 30 g.
- 12. Canned foods and canned pet foods, when sold by a New Zealand manufacturer whose annual turnover in the manufacture of canned foods or canned pet foods or both exceeds \$1,000,000.
- 13. Eggs of domestic fowls and the distribution and handling of such eggs.
 - 14. Flour, which term—
 - (a) Includes—

(i) Gluten; and

(ii) Wheatmeal, except when sold in packs of 5 kg or less by retailers and wholesalers other than the New Zealand Wheat Board or its agents; and

(iii) Wholemeal, except when sold in packs of 5 kg or less by retailers and wholesalers other than the New Zealand Wheat Board or its agents; but

(b) Does not include-

- (i) Self-raising flour; or
- (ii) Soya bean flour; or
- (iii) Rye flour.

15. Intoxicating liquor, as follows:

(a) All intoxicating liquor sold in public bars of hotels, taverns, or other premises licensed under the Sale of Liquor Act 1962, or deemed to be licensed under the Act pursuant to the Licensing Trusts Act 1949, or the Masterton Licensing Trust Act 1947, or the Invercargill Licensing Trust Act 1950; and

- (b) All draught beer in flagons, and bottled beer in bottles containing not less than 745 millilitres, sold for consumption off the premises in hotels, taverns, or other premises licensed under the Sale of Liquor Act 1962, or deemed to be licensed under that Act pursuant to the Licensing Trusts Act 1949, or the Masterton Licensing Trust Act 1947, or the Invercargill Licensing Trust Act 1950.
- 16. Beer, manufacturers' and packers' prices.
- 17. Spirits, manufacturers' and packers' prices.
- 18. Oranges, imported, when sold by a retailer.
- 19. Soap, washing powder, and detergent, when sold by a New Zealand manufacturer whose annual turnover in the manufacture of soap or washing powder or detergent or any two or more of those kinds of goods exceeds \$1,000,000.
 - 20. Sugar, which term does not include—
 - (a) Raw sugar; or
 - (b) No. 3 brown sugar; or
 - (c) Castor sugar; or
 - (d) Icing sugar; or
 - (e) Loaf sugar; or
 - (f) Coffee sugar crystals.
 - 21. Tobacco products of the following kinds:
 - (a) Cigarettes manufactured in New Zealand; and
 - (b) Tobacco manufactured in New Zealand, not being raw tobacco as defined in the Tobacco Growing Industry Act 1974.
- 22. Vegetables, dried or frozen, with or without other ingredients, when sold by a New Zealand manufacturer whose annual turnover in the manufacture of such goods exceeds \$1,000,000.

Hardware

- 23. Aluminium, in the form of sheet or foil, when sold by the New Zealand manufacturer of such goods.
- 24. Aluminium alloys, in the form of sheet or foil, when sold by the New Zealand manufacturer of such goods.
 - 25. Bolts made of steel and nuts made of steel.
- 26. Lead, in the form of sheet or strip, when sold by the New Zealand manufacturer of such goods.
- 27. Lead alloys, in the form of sheet or strip, when sold by the New Zealand manufacturer of such goods.
- 28. Metal pipes, including those made in the form of rectangular hollow sections.
 - 29. Metal pipe fittings (except pipe fittings made of brass).
 - 30. Steel—
 - (a) In the form of billet, sheet, strip, bar, rod, wire rod, or tube;
 - (b) In the form of angles; and
 - (c) In sectional shapes.

- 31. Steel, galvanised or galvanised and prepainted, in the form of flat sheet or coil.
- 32. Wire made of steel, including reinforcing wire, nail wire, bending and cross welding wire, electrode wire, fencing wire, manufacturing wire, and barbed wire.

Vehicles

- 33. Motor vehicles (including chassis and cabs) of the following kinds:

GOODS AND SERVICES CONTROLLED BY THE SECRETARY OF ENERGY

1. Gas, natural or manufactured, other than—

(a) Natural gas sold under—

- (i) The Gas Purchase Contract made on the 31st day of July 1967 between Shell (Petroleum Mining) Company Ltd., B.P. (Oil Exploration) Company of New Zealand Ltd., Todd Petroleum Mining Company Ltd., as the sellers and the Minister of Mines as the buyer; or
- (ii) The Maui Gas Sale and Purchase Contract made on the 1st day of October 1973 between Offshore Mining Company Ltd., Shell (Petroleum Mining) Company Ltd., B.P. (Oil Exploration) Company of New Zealand Ltd., and Todd Petroleum Mining Company Ltd., as the sellers and the New Zealand Government as the buyer; and
- (b) Compressed natural gas sold for use as an automotive fuel.
- 2. Liquefied petroleum gas as defined in the Natural Gas Corporation Act 1967.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice is an extensive revision of the Positive List of Controlled Goods and Services. The goods and services specified in the list are the goods and services subject to price control under Part IV of the Commerce Act 1975. The goods and services in the First Schedule are controlled by the Secretary of Trade and Industry. The goods and services in the Second Schedule are controlled by the Secretary of Energy.

 (d) The alteration of the item relating to nuts and bolts so that only steel nuts and steel bolts are subject to the notice:
