THE POSITIVE LIST OF CONTROLLED GOODS AND SERVICES 1981, AMENDMENT NO. 15

PURSUANT to section 82 of the Commerce Act 1975, the Minister of Trade and Industry hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Positive List of Controlled Goods and Services 1981, Amendment No. 15, and shall be read together with and deemed part of the Positive List of Controlled Goods and Services 1981* (hereinafter referred to as the principal notice).

(2) Except as provided in subclause (3) of this clause, this notice shall come into force on the 25th day of November 1985.

(3) Clause 4 of this notice shall come into force on the 1st day of January 1986.

2. First Schedule amended by omitting item No. 19—The First Schedule to the principal notice is hereby amended by omitting item No. 19 (an item relating to soap, washing powder and detergent).

3. First Schedule amended by substituting new item No. 22—The First Schedule to the principal notice is hereby amended by omitting item No. 22, and substituting the following item:

"22. Frozen vegetables with or without other ingredients when sold by a New Zealand manufacturer whose annual turnover in the manufacture of such goods exceeds \$1,000,000."

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice exempts soap, washing powder and detergent and dried vegetables from price control with effect from 25 November 1985. It also exempts aluminium in the form of sheet or foil and aluminium alloys in the form of sheet or foil from price control with effect from 1 January 1986.
