NOTICE

1. Title and commencement—(1) This notice may be cited as the Positive List of Controlled Goods and Services 1981, Amendment No. 18, and shall be read together with and deemed part of the Positive List of Controlled Goods and Services 1981* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the 22nd day of April 1986.

2. Steel pipes—The First Schedule to the principal notice is hereby amended by omitting item No. 28, and substituting the following item:

“28. Steel pipes, including those made in the form of rectangular hollow sections, when manufactured and sold by New Zealand Steel Limited.”

3. Metal pipe fittings—The First Schedule to the principal notice is hereby amended by omitting item No. 29 (an item relating to metal pipe fittings).

4. Steel—The First Schedule to the principal notice (as amended by clause 2 of the Positive List of Controlled Goods and Services 1981, Amendment No. 14) is hereby amended by omitting item No. 30 and item No. 31, and substituting the following items:

“30. Steel, in the form of billet, sheet, strip, or tube, when manufactured and sold by New Zealand Steel Limited.

“31. Steel, galvanised or galvanised and prepainted, in the form of flat sheet or coil, when sold by the New Zealand manufacturer.”

5. Wire made of steel—The First Schedule to the principal notice (as amended by clause 3 of the Positive List of Controlled Goods and Services 1981, Amendment No. 14) is hereby amended by omitting item No. 32 (an item relating to wire made of steel).

6. Revocation—The Positive List of Controlled Goods and Services 1981, Amendment No. 14 is hereby revoked.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on 22 April 1986, exempts from price control the following items:

- (a) Metal pipes, except steel pipes manufactured and sold by New Zealand Steel Limited:

- (d) Steel, galvanised or galvanised and prepainted, except when sold by the New Zealand manufacturer:
