**THE POSITIVE LIST OF CONTROLLED GOODS AND SERVICES

NOTICE

(2) This notice shall come into force on the 30th day of April 1986.

“(ii) The Maui Gas Sale and Purchase Contract made on the 1st day of October 1973 between Offshore Mining Company Ltd., Shell (Petroleum Mining) Company Ltd., B.P. (Oil Exploration) Company of New Zealand Ltd., and Todd

Petroleum Mining Company Ltd., as the sellers and the New Zealand Government as the buyer; and

“(b) Compressed natural gas sold for use as an automotive fuel; and

“(c) Natural gas sold by the Natural Gas Corporation of New Zealand Limited to—

“(i) The Auckland Gas Company Limited; or

“(ii) The Hamilton City Council; or

“(iii) The New Plymouth City Council; or

“(iv) East Coast Gas Supply Limited; or

“(v) The Levin Borough Council; or

“(vi) The Hawera Gas Company Limited; or

“(vii) The Wanganui City Council; or

“(viii) The Palmerston North City Council; or

“(ix) The Wellington Gas Company Limited; or

“(x) The Hutt Valley Energy Board.”

11. Revocations—The notices specified in the Schedule to this notice are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

The notice, which comes into force on 30 April 1986 exempts from price control the following items:

- (a) Sheet window glass, manufactured in New Zealand, when sold by the manufacturer:
- (b) Apples and pears, when sold by a retailer:
- (c) Canned foods (except canned fruit) and canned pet foods when sold by a New Zealand manufacturer whose annual turnover in the manufacture of canned foods (except canned fruit) or canned pet foods or both exceeds \$1,000,000:
- (d) Sugar, other than—
 - (i) Raw sugar; or
 - (ii) No. 3 brown sugar; or
 - (iii) Castor sugar; or
 - (iv) Icing sugar; or
 - (v) Loaf sugar; or
 - (vi) Coffee sugar crystals:
- (e) Frozen vegetables with or without other ingredients when sold by a New Zealand manufacturer whose annual turnover in the manufacture of such goods exceeds \$1,000,000:
- (f) Steel, galvanised or galvanised and pre-painted in the form of flat sheet or coil, when sold by the New Zealand manufacturer other than New Zealand Steel Limited:
- (g) Wheat broking:
- (h) Ceramic tableware, ceramic kitchenware, and ceramic household fittings as follows:
 - (a) Imported:
 - (b) New Zealand manufactured, when sold by a manufacturer whose annual turnover in the manufacture of such goods exceeds \$1,000,000:
