## THE PIG MARKETING EMERGENCY REGULATIONS 1943, AMENDMENT NO. 2

At the Government House at Wellington, this 28th day of July, 1943

### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

### REGULATIONS

- 1. These regulations may be cited as the Pig Marketing Emergency Regulations 1943, Amendment No. 2, and shall be read together with and deemed part of the Pig Marketing Emergency Regulations 1943\* (hereinafter referred to as the principal regulations).
- 2. (1) Regulation 3 of the principal regulations is hereby amended by inserting in subclause (1), after the definition of the term "baconer", the following definition:—
  - "'Chopper' means a pig which when killed and dressed will have a dressed weight (including the head) of more than 180 lb., or any other pig which is graded as a chopper; and includes the carcass of any such pig:".
- (2) The said Regulation 3 is hereby further amended by inserting in subclause (1), after the definition of the term "establishment", the following definition:—
  - "'Fresh-killed', in relation to any meat, includes meat which has been chilled but not frozen:".
- 3. Regulation 4 of the principal regulations is hereby amended by inserting, after the words "overweight baconer", the words "or a chopper".

- 4. (1) The principal regulations are hereby amended by revoking Regulation 5, and substituting the following regulation:—
- "5. The maximum price at which an operator may purchase any pig, being a porker, a baconer, an overweight baconer, or a chopper, shall be a sum calculated, by reference to the weight of the pig when killed and dressed, according to such scale of prices as the Minister may from time to time fix for the purposes of this regulation by notice published in the *Gazette*."
- (2) The First Schedule to the principal regulations is hereby revoked.
- 5. (1) The principal regulations are hereby further amended by revoking Regulation 8, and substituting the following regulation:—
- "8. (1) The Department may from time to time acquire in the manner hereinafter appearing any meat of the following classes:—
  - "(a) Fresh-killed and dressed careasses of porkers, baconers, overweight baconers, or choppers which are in any establishment:
  - "(b) Pork sides or Wiltshire sides which are in any establishment, whether they are fresh-killed or frozen and whether the pigs from which they were derived were killed before or after the commencement of these regulations:
  - "(c) Frozen carcasses of porkers, baconers, overweight baconers, or choppers which are in any establishment, whether the pigs from which they were derived were killed before or after the commencement of these regulations:
  - "(d) Any other class or description of meat, whether fresh-killed or frozen, which is in any establishment and which has been derived from porkers, baconers, overweight baconers, or choppers, whether killed before or after the commencement of these regulations.
- "(2) Nothing in the Meat Marketing Order 1942\* shall apply with respect to pig-meats acquired by the Department under these regulations."
- (2) The Pig Marketing Emergency Regulations 1943, Amendment No. 1†, is hereby revoked.
- **6.** (1) Regulation 13 of the principal regulations is hereby amended by omitting the words "in accordance with the scale of basic values set out in the Second Schedule to these regulations", and substituting the words "in accordance with such scale of basic values as the Minister may from time to time fix for the purposes of this regulation by notice published in the *Gazette*."
- (2) The Second Schedule to the principal regulations is hereby revoked.

- 7. Regulation 14 of the principal regulations is hereby amended by revoking subclause (3), and substituting the following new subclause:—
- "(3) In the case of meat the property wherein vests in the Department before the meat is frozen, the price shall be the maximum price at which an operator could have purchased, on a 'graded' basis, the pig from which the meat was derived:
- "Provided that the Department shall pay to the proprietor of the establishment in which the meat is held such charges as may be payable to him with respect to the meat."
