THE POSTAL NOTE REGULATIONS 1940, AMENDMENT NO. 3


#### Abstract

BERNARD FERGUSSON, Governor-General ORDER IN COUNCIL

At the Government House at Wellington this 5th day of July 1967 Present: His Excellengy the Governor-General in Council Pursuant to the Post Office Act 1959, His Excellency the GovernorGeneral, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.


## REGULATIONS

1. (1) These regulations may be cited as the Postal Note Regulations 1940, Amendment No. 3, and shall be read together with and deemed part of the Postal Note Regulations 1940* (hereinafter referred to as the principal regulations).
(2) These regulations shall come into force on the 10 th day of July 1967.
2. (1) The principal regulations are hereby amended by revoking regulation 6 (as amended by regulation 2 of the Postal Note Regulations 1940, Amendment No. 1) and substituting the following regulation:
" 6 . Every postal note shall be numbered, and shall be for one of the following amounts, and in respect of each postal note the following commission shall be paid:

(2) The Postal Note Regulations 1940, Amendment No. 1, are hereby revoked.

[^0]3. Regulation 11 of the principal regulations is hereby amended by omitting the words "sign the note with his initials and".
4. The principal regulations are hereby amended by revoking regulation 12, and substituting the following regulation:
"12. Unused postage stamps (not being fractions of a cent) not exceeding three in number and 4 c in value may be affixed to the front of postal notes of the denominations 20c, $25 \mathrm{c}, 70 \mathrm{c}$, and 75 c . Unused postage stamps (not being fractions of a cent) not exceeding three in number and 9 c in value may be affixed to the front of all other denominations of postal notes."
5. Regulation 26 of the principal regulations is hereby amended by omitting the words "and affix his initials".

## EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend monetary amounts in the regulations to read in decimal currency.

Regulations 11 and 26 have been amended to make it no longer necessary for an officer to initial a postal note.
