PRICE ORDER NO. 119

PURSUANT to the powers conferred on it by the Control of Prices Emergency Regulations 1939,* the Price Tribunal, acting with the authority of the Minister of Industries and Commerce, doth hereby make the following Price Order :—

1. This Order may be cited as Price Order No. 119, and shall come into force on the 14th day of December, 1942.

APPLICATION OF THIS ORDER.

2. This Order applies with respect to all sales of bananas by way of retail sale.

3. The provisions of this Order fixing prices by reference to the weight of the bananas to which any sale relates shall apply notwithstanding that in any such case the retailer may sell or purport to sell otherwise than by weight.

FIXING MAXIMUM RETAIL PRICES OF BANANAS.

4. (1) The maximum price that may be charged or received by any retailer for any bananas to which this Order applies shall be determined as follows :—

	Maximum Retail Price per Pound.
(i) In the case of bananas sold at any place within the metropolitan areas of Auckland, Wellington, Christchurch, or Dunedin as respectively defined in the Schedule hereto	d. 7
(ii) In the case of bananas sold elsewhere in New Zealand	7½

(2) Where the quantity of bananas sold by a retailer in any one transaction is not an exact number of pounds, the maximum price shall be computed at the rate per pound fixed in accordance with the last preceding subclause :

Provided that if the price computed as aforesaid is not an exact number of pence or halfpence, the maximum price shall be computed to the nearest upward halfpenny.

SCHEDULE.

DEFINITION OF METROPOLITAN AREAS.

Name of Metropolitan Area.	Districts included therein.
Auckland ..	The city of Auckland ; the boroughs of Birkenhead, Devonport, Ellerslie, Mount Albert, Mount Eden, New Lynn, Newmarket, Northcote, Onehunga, One Tree Hill, Otahuhu, and Takapuna ; and the road districts of Mount Roskill, Mount Wellington, and Panmure Township.
Wellington ..	The cities of Wellington and Lower Hutt ; the boroughs of Eastbourne and Petone ; and the town district of Johnsonville.
Christchurch ..	The city of Christchurch and the boroughs of Lyttelton, New Brighton, Riccarton, and Sumner.
Dunedin ..	The city of Dunedin and the boroughs of Green Island, Port Chalmers, St. Kilda, and West Harbour.
