PRICE ORDER NO. 6.

IN pursuance of the powers conferred upon the Price Tribunal by the Control of Prices Emergency Regulations 1939, and with the authority of the Minister of Industries and Commerce, the Price Tribunal hereby makes the following Price Order :---

1. This Order may be cited as Price Order No. 6.

2. The maximum price at which nails of the gauges or kinds mentioned in the first column of the Schedule hereto may be sold in Auckland, Wellington, Christchurch, or Dunedin by way of wholesale and by way of retail shall be the prices fixed in the second and third columns of the said Schedule respectively opposite the name of such gauge or kind, subject, however, as hereinafter provided.

3. Where a sale is made by way of wholesale in a quantity of half a hundredweight or of one-quarter of a hundredweight of any one gauge or kind of nail, an additional price equivalent to 2s. per hundredweight or 4s. per hundredweight respectively is authorized.

4. The maximum price at which nails mentioned in the first column of the said Schedule may be sold at places other than Auckland, Wellington, Christchurch, and Dunedin shall be the prices fixed in the said Schedule increased by the actual amount of extra freight and/or carriage cost from warehouse into store.

5. Where a sale is made by way of wholesale to a reseller, the price fixed in the said Schedule shall be reduced by an amount equivalent to 2s. per hundredweight.

6. All prices fixed by this Order shall be "net" and shall be deemed to include any sales tax chargeable.
