# THE POST OFFICE (POSTAL NOTE) REGULATIONS 1969, AMENDMENT NO. 2

# ORDER IN COUNCIL

At the Government House at Wellington this 26th day of January 1976

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Post Office Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Post Office (Postal Note) Regulations 1969, Amendment No. 2, and shall be read together with and deemed part of the Post Office (Postal Note) Regulations 1969\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 2nd day of February 1976.

2. Commission—(1) Regulation 3 of the principal regulations is hereby amended by revoking subclause (6) (as substituted by regulation 2 of the Post Office (Postal Note) Regulations 1969, Amendment No. 1), and substituting the following subclause:

"(6) A postal note may be issued for one of the amounts specified in the first column of the following table, and in respect of any postal note issued under this regulation the commission specified in the second column of that table shall be payable by its purchaser:

(2) The Post Office (Postal Note) Regulations, Amendment No. 1, are hereby consequentially revoked.

3. Duplicate notes-Regulation 9 of the principal regulations is hereby amended by revoking subclause (8), and substituting the following subclause:

"(8) The fee for the issue of an order or orders in respect of a postal note or postal notes proved to comprise a single remittance of a specified sum shall be 20 cents; but if it appears after investigation that the note or notes were lost in transmission through the post, the order or orders shall be issued free of charge. No fee shall be payable for an order made in respect of a gift token.

4. Information relating to postal notes-Regulation 14 of the principal regulations is hereby amended by revoking subclauses (1) and (2), and substituting the following subclauses:

"(1) Any person claiming to be the purchaser, remitter, recipient, or payee of a postal note may, within 2 years after the date of issue on making written application giving full details of the note and upon payment of a fee of 20 cents, obtain information relative to the payment in respect of the note.

(2) If the applicant is unable to give full details of the note, and a search of the records is necessary, he shall be required to pay a fee of \$1.60 for each period of 30 minutes or part thereof of the time involved in the search."

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations increase the commission and miscellaneous charges payable in respect of postal notes with effect from 2 February 1976.
