HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Post Office Act 1959, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Post Office (Money Order) Regulations 1974, Amendment No. 3, and shall be read together with and deemed part of the Post Office (Money Order) Regulations 1974\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of October 1979.

**2. Charges**—(1) The principal regulations are hereby amended by revoking the First Schedule (as inserted by regulation 2 of the Post Office (Money Order) Regulations 1974, Amendment No. 2), and substituting the new First Schedule set out in the Schedule hereto.

(2) The Post Office (Money Order) Regulations 1974, Amendment No. 2, are hereby revoked.

## SCHEDULE

## NEW FIRST SCHEDULE TO PRINCIPAL REGULATIONS

## "FIRST SCHEDULE

## CHARGES

**1. Commission charges for money orders (Reg. 6)**—The following commission charges shall be payable:

- (a) Postal money orders payable in New Zealand, the Cook Islands, Niue, and Western Samoa 25 cents for any amount not exceeding \$20 and an additional 5 cents for each additional \$20 or fraction thereof.
- (b) Postal money orders payable overseas (except in the Cook Islands, Niue, and Western Samoa) 70 cents for any amount up to the maximum amount for which a postal money order may be issued.

**2. Commission and telegraph charges for telegraph money orders (Reg. 6)**—The following combined commission and telegraph charges shall be payable:

- (a) Telegraph money orders payable in New Zealand only A combined commission and telegraph charge of \$3.60 for any amount if sent at ordinary rates and \$4.20 if sent urgent, together with 6 cents for each word included in any private message added to the official telegram.
- (b) Telegraph money orders payable in the Cook Islands, Niue, and Western Samoa A combined commission and telegraph charge of \$4 plus 12 cents for each word included in any private message added to the official telegram.
- (c) To Australia A charge consisting of 70 cents commission and telegraph charges at current ordinary or letter-telegram rates for the official telegram and for any private message included.
- (d) To Fiji and Norfolk Island A charge consisting of 70 cents commission and telegraph charges at current ordinary rates for the official telegram and for any private message included.
- (e) To the United Kingdom and to the Irish Republic A charge consisting of 70 cents commission and telegraph charges at current ordinary or letter-telegram rates for the official telegram and any private message included.

**3. Information relating to money orders (Reg. 16)**—(1) A fee of 20 cents shall be payable in respect of each application made at the time of the issue of a money order to receive official advice of its payment.
