# THE POST OFFICE (INLAND POST) REGULATIONS 1977, AMENDMENT NO. 8

## ORDER IN COUNCIL

At Wellington this 10th day of March 1986
Present:
His Excellency the Governor-General in Council
Pursuant to the Post Office Act 1959, His Excellency the GovernorGeneral, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

1. Title and commencement-(1) These regulations may be cited as the Post Office (Inland Post) Regulations 1977, Amendment No. 8, and shall be read together with and deemed part of the Post Office (Inland Post) Regulations 1977* (hereinafter referred to as the principal regulations).
(2) Subject to subclause (3) of this regulation, these regulations shall come into force on the lst day of April 1986.
(3) Regulation 4 of these regulations shall come into force on the 1st day of May 1986.
2. Conditions as to claim for compensation-(1) Regulation 49 (2) of the principal regulations is hereby amended by revoking paragraph (c), and substituting the following paragraph:
"(c) Claims for any uninsured or unregistered postal articles made later than 6 months after the date of posting:".
(2) Regulation 49 (2) of the principal regulations is hereby further amended by adding the following paragraph:
"(e) Uninsured or unregistered non-standard articles posted in enveloped form."
3. First Schedule-For the period commencing on the 1st day of April 1986 and ending with the 30th day of April 1986, the First Schedule to the principal regulations (as substituted by regulation 7 (1) of the Post Office (Inland Post) Regulations 1977, Amendment No. 7) shall be read as if there had been substituted for subclauses (12), (13), and (14) of clause 3 of that Schedule subclauses (12), (13), and (14) of clause 3 of the new First Schedule to the principal regulations as set out in the Schedule to these regulations.
4. Inland postage rates and fees for other services-(1) The principal regulations are hereby amended by revoking the First Schedule (as substituted by regulation 7 (1) of the Post Office (Inland Post) Regulations 1977, Amendment No. 7), and substituting the new First Schedule set out in the Schedule to these regulations.
(2) The Post Office (Inland Post) Regulations 1977, Amendment No. 7 are hereby consequentially amended by revoking regulation 7 and the Schedule thereto.

(b) Exceeding standard letter dimensions and requiring first-class priority
publication less a discount of 50 percent:
55c for each copy of a registered publication weighing up to 100 g :
80 c for each copy of a registered publication weighing over 100 g , but not exceeding 250 g :
$\$ 1.25$ for each copy of a registered publication weighing over 250 g , but not exceeding 500 g :
$\$ 1.70$ for each copy of a registered publication weighing over 500 g , but not exceeding 1 kg :
Less a discount of 50 percent in all cases.

(d) Unaddressed mail prescribed in paragraph (c) (i), (ii), and (iii) of this subclause is available for delivery to rural boxholders, to private letterbox lessees, to private mail bag lessees, or over the post office counter.
(6) Parcels-The postage rates for parcels are assessed on the basis of the following zones:
(a) Parcels delivered within a district or within 50 kilometres of the office of posting (except inter-island):
(b) All other parcel deliveries within an island:
(c) Inter-island parcel deliveries.

3. Miscellaneous rates and charges-The following miscellaneous rates and charges shall be payable:
(1) Fee for registration of a publication-A fee of $\$ 27$ is payable upon the initial registration of a publication. A further fee of $\$ 20$ is payable in respect of each annual renewal of registration.
(2) Literature for the blind-No postage is payable in respect of literature posted for blind persons if the article weighs not more than 7 kg .
(3) Express delivery packages-The fee payable in respect of packages delivered by express delivery up to 5 km is $\$ 1.30$ in addition to postage.
(4) Business reply and Freepost-The following charges shall be payable in addition to postage in respect of items sent "business reply post" or "freepost":
(a) For 500 or more items per month to the same addressee provided such conditions as may be
$\$ 15$ per month: notified from time to time by the PostmasterGeneral in the Post Office Guide are met
(b) For all other items

(5) Insurance-The following fees are payable, in addition to postage, in respect of insured articles:
(a) For any article insured for an amount up to $\$ 100$. $\$ 2.70$
(b) For each additional $\$ 50$ of insurance cover or fraction thereof up to a maximum of $\$ 1,000$

(6) Registration-The fee payable, in addition to postage, in respect of registered letters is $\$ 1.75$.
(7) Advice of delivery of a registered or insured article-
(a) The charge payable in respect of an advice of delivery of a registered or an insured article is $\$ 1.20$.
(b) The charge payable for obtaining a certificate of delivery of a registered or an insured article up to 1 year after the date of posting is $\$ 1.75$.
(8) Late fee-The late fee payable in respect of a letter is 30 c in addition to postage.
(9) Customs clearance fee-For each postal article a Customs clearance fee of $\$ 1.70$ is payable.
(10) Storage-The following storage fees are payable in respect of postal articles:
(a) If the article is collected within 5 working days after the 40 c per end of the free storage period
day:
(b) If the article is collected after the expiration of the period referred to in paragraph (a) of this clause for each day beyond the expiration of the free storage 80c per period, including weekends and public holidays day.
(11) Pharmaceutical requirements-For each package of pharmaceutical requirements posted by a pharmacist under the Social Security (Pharmaceutical Benefits) Regulations 1965 a fee of 25 c additional to postage shall be payable by the addressee.
(12) Private letterbox rental rates-The following charges are payable in respect of the renting of private letterboxes:

(13) Private mail bag charges-
(a) The fee for a private bag for the delivery of correspondence to an address which is within an area served by a postman's delivery shall be as follows:
(i) For a bag that is collected at the post office by the holder:
$\$ 160$ a year for each closing a day, Monday to Friday:
$\$ 48$ a year for each closing on Saturday:
$\$ 65$ a year for each closing on Sunday:
(ii) For a bag that is delivered by the Post Office:
$\$ 160$ a year for each closing a day, Monday to Friday:
$\$ 48$ a year for each closing on Saturday:
$\$ 65$ a year for each closing on Sunday:
There is also payable under subparagraph (a) (ii) of this paragraph, a delivery charge of $\$ 270$ per annum for each closing

a day if the bagholder resides within 5 kilometres of the delivery office, a further $\$ 335$ per annum for each closing a day if the bagholder resides between 5 and 10 kilometres of the delivery office, and an additional charge of $\$ 107$ per annum for each additional kilometre or part thereof of delivery:
(b) The fee for a private bag for the delivery of correspondence to an address that is outside an area served by a postman's delivery shall be as follows:

NOTE-The rural mail delivery fee is charged for a rural private bag when the customer does not have the option of rural delivery service.
(14) Rural mail service charges-

(15) Redirection orders-A charge of $\$ 17.00$ is payable in respect of each renewal of a redirection order after a period of 12 months.
(16) Surcharge on unpaid or underpaid mail-The fee payable, in addition to the deficient postage in respect of unpaid or underpaid postal articles, is 30 c per article."

## EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.
These regulations, which come into force on 1 April 1986, amend the Post Office (Inland Post) Regulations 1977 to-
(a) Change the conditions as to claims for compensation in respect of the loss of or damage to any unregistered or uninsured postal article not in enveloped form:
(b) Prescribe new rates for private letterboxes, private mail bags, and rural mail service:
(c) Prescribe new charges for all other postal services with effect from 1 May 1986.

Issued under the authority of the Regulations Act 1936.
Date of notification in Gazette: 13 March 1986.
These regulations are administered in the Post Office.
