



**THE PURCHASE OF WOOL EMERGENCY REGULATIONS
1939, AMENDMENT NO. 2**

ORDER IN COUNCIL

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Purchase of Wool Emergency Regulations 1939, Amendment No. 2, and shall be read together with and deemed part of the Purchase of Wool Emergency Regulations 1939* (hereinafter referred to as the principal regulations).

2. Regulation 5 of the Purchase of Wool Emergency Regulations 1939, Amendment No. 1, is hereby amended as follows:—

- (a) By omitting from paragraph (a) of subclause (4) the words “by the issue in the name of the owner of New Zealand Government stock (to be known as Wool Deferred Payment Stock) for that amount”, and substituting the words “by the issue of National Savings Bonds under the National Savings Act, 1940, or, at the option of the owner notified to the Treasury not later than the 10th day of July, 1943, by the issue of 2½ per cent. or 3 per cent. stock in the Third Liberty Loan or by investment in a National Savings Investment Account under the National Savings Act, 1940”:
- (b) By omitting from subclause (5) the words “Wool Deferred Payment Stock” wherever those words occur, and substituting in each case the words “bonds, securities, certificates of registration”.

3. Regulation 6 of the Purchase of Wool Emergency Regulations 1939, Amendment No. 1, is hereby revoked, and the following regulation is hereby substituted therefor:—

“6. Interest on all bonds, stock, and investments issued or made for the purposes of paragraph (a) of Regulation 5 (4) hereof shall be calculated from the 1st day of February, 1943.”

4. Regulation 7 of the Purchase of Wool Emergency Regulations 1939, Amendment No. 1, is hereby amended by omitting from subclause (1) the words “any Wool Deferred Payment Stock is to be issued for any amount under these regulations”, and substituting the words “any amount is to be paid under these regulations otherwise than in cash”.
