THE PATRIOTIC PURPOSES EMERGENCY REGULATIONS 1939, AMENDMENT NO. 1.

GALWAY, Governor-General.

ORDER IN COUNCIL.

At the Government House at Wellington, this 8th day of November, 1939.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

- 1. These regulations may be cited as the Patriotic Purposes Emergency Regulations 1939, Amendment No. 1.
- 2. These regulations shall be read together with and form part of the Patriotic Purposes Emergency Regulations 1939* (hereinafter referred to as the principal regulations).
 - 3. Regulation 4 of the principal regulations is amended—
 - (a) By revoking clause (4) thereof, and substituting the following:—
 - "(4) There shall be paid to each member of the Council, other than persons (if any) in the service of the Government, all travelling and locomotion expenses (including the cost of sleeping-berths on trains and deck accommodation on steamers) actually and reasonably expended in respect of their attendance at meetings of the Council or their travelling with the authority of the Minister on the business of the Council. In exceptional cases the Minister may approve of a member of the Council travelling in his own conveyance in transacting any business of the Council. The mileage rate shall be the same as that payable to officers of the Public Service."

(b) By adding at the end thereof the following clause:—

"(5) Each member of the Council shall be paid the sum of £1 5s. as a travelling-allowance for personal expenses for each complete day on which he is absent from his head-quarters in connection with the business of the Council. For any portion of a day the rate shall be one twenty-fourth of the full daily rate for each hour's absence. When a member leaves and returns to his usual headquarters on the same day, actual and reasonable expenses only shall be paid."

- 4. Regulation 13 of the principal regulations is amended by revoking the word "Account" in clause (3) and by inserting next after clause (3) the following clause:—
 - "(4) The National Patriotic Fund Account shall be operated on only by cheque signed by the Treasurer of the Fund duly appointed under these regulations and countersigned by any two of such members of the Board as the Board appoints for that purpose."

5. Regulation 14 of the principal regulations is amended—

(a) By revoking clause (4) thereof, and substituting the following:—
"(4) The members of the Board, other than the Governor-General and persons (if any) in the service of the Government, shall be paid all travelling and locomotion expenses (including the cost of sleeping-berths on trains and deck accommodation on steamers) actually and reasonably expended in respect of their attendance at meetings of the Board or their travelling with the authority of the Minister on the business of the Board. In exceptional cases the Minister may approve of a member of the Board travelling in his own conveyance in transacting any business of the Board. The mileage rate shall be the same as that payable to officers of the Public Service."

(b) By adding at the end thereof the following clause:-

- "(5) Each member of the Board shall be paid the sum of £1 5s. as a travelling-allowance for personal expenses for each complete day on which he is absent from his head-quarters in connection with the business of the Board. For any portion of a day the rate shall be one twenty-fourth of the full daily rate for each hour's absence. When a member leaves and returns to his usual headquarters on the same day, actual and reasonable expenses only shall be paid."
- 6. The principal regulations are amended by inserting next after Regulation 32 the following regulation:—
- "REGULATION 32A.—CONTRIBUTIONS BY CENTENNIAL ORGANIZATIONS TO PATRIOTIC FUNDS.
- "(1) Any Provincial Centennial Council or controlling committee within its district may from time to time make application to the Minister for authority to pay to the National Fund or to any Provincial Patriotic Fund any moneys held by it for the purposes of the New Zealand Centennial Act, 1938.

- "(2) The Minister may, upon application being made to him as aforesaid, cause to be made such inquiry and investigation as he thinks fit, and if he is satisfied that such moneys or any part thereof are no longer required for Centennial purposes, or cannot reasonably be expended therefor, and that the Provincial Council or controlling committee has done all that can reasonably be expected of it under the circumstances prevailing at the date of the application for the proper celebration of the Centennial within its district, the Minister may, by writing under his hand, grant such authority subject to such terms and conditions as he may think fit to impose. The Provincial Council or controlling committee may thereupon, subject to such terms and conditions as aforesaid, pay to the National Fund or to a Provincial Patriotic Fund, according as the Minister names and directs in such writing, the amount specified therein, anything to the contrary in the New Zealand Centennial Act, 1938, notwithstanding."
- 7. The principal regulations are amended by inserting next after Regulation 35 the following regulation:—
 - "REGULATION 36.--EXEMPTION FROM STAMP DUTY.

"No stamp duty shall be payable on any cheque or receipt issued or given by or on behalf of any person or body of persons, whether incorporated or not, under the authority of these regulations."
