# THE PETROLEUM PIPELINES REGULATIONS 1964, AMENDMENT NO. 1

## ORDER IN COUNCIL

At the Government House at Wellington this 18th day of December 1967

Present: HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Petroleum Act 1937, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Petroleum Pipelines Regulations 1964, Amendment No. 1, and shall be read together with and deemed part of the Petroleum Pipelines Regulations 1964\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. Pipeline easement certificates (in respect of roads)—Form 4 in the First Schedule to the principal regulations is hereby amended by adding to paragraph 2 the words "or marked 'Pipeline'.".

3. Pipeline easement certificates (in respect of land not on road)— Form 5 in the First Schedule to the principal regulations is hereby amended as follows:

(a) By adding to paragraph 3 the words "or marked 'Pipeline'.":

(b) By omitting from paragraph 5 the words "for thirty (30) feet", and substituting the words "for ...... feet (being not more than 30 feet)":

- (c) By omitting from paragraph 5 the words "No structure shall be erected on the said strip without the consent of the owner of the pipeline.":
- (d) By adding to paragraph 6 the words "but shall not erect any building, construction, or fence or plant any tree or shrub on the said strip, disturb the soil of the said strip below a depth of fifteen inches from the surface or do anything which would or could damage or endanger the pipeline without the consent of the owner of the pipeline being first obtained. Any such consent shall not be unreasonably withheld.":
- (e) By inserting in paragraph 8, after the word "will", the words "restore or".

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the forms of pipeline easement certificates set out in the First Schedule to the Petroleum Pipelines Regulations 1964. Regulation 2 amends the Certificate to be used where the pipeline is along

Regulation 2 amends the Certificate to be used where the pipeline is along a road by providing for the pipeline to be shown by a notation as an alternative to a colouring.

to a colouring. Regulation 3 amends the Certificate to be used where the pipeline is not along a road.
