## THE PLUMBERS REGULATIONS 1931, AMENDMENT NO. 10

C. L. N. NEWALL, Governor-General. ORDER IN COUNCIL.

At the Government Buildings at Wellington, this 25th day of February, 1942.

## Present:

THE RIGHT HON. P. FRASER PRESIDING IN COUNCIL.

PURSUANT to the Plumbers Registration Act, 1912, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations for matters which have been deemed by the Plumbers Board of New Zealand necessary or expedient to give effect to the said Act.

## REGULATIONS.

- 1. These regulations may be cited as the Plumbers Regulations 1931, Amendment No. 10.
- 2. These regulations shall be read with and form part of the Plumbers Regulations 1931\* (hereinafter called the principal regulations).
- 3. Regulation 4 of the principal regulations is amended by adding thereto the following additional clauses:-

"(9) The Board may, in its discretion, permit any person—

"(a) Who satisfies the Board that he has been accepted for service within New Zealand for the duration of the war in which His Majesty is now engaged with any of His Majesty's Forces; and

- "(b) Who except as hereinafter mentioned is otherwise eligible; and
- "(c) Who has served for at least four and a half years as an apprentice in the plumbing trade—

to present himself for the examination or either part thereof notwithstanding that he may not have complied with the requirements of clause (7) of this regulation.

"(10) Nothing in clause (8) or clause (9) of this regulation shall authorize the granting of a certificate of having passed an examination until the provisions of paragraph (b) of section 17 of the said Act have been complied with."
