THE POULTRY REGULATIONS 1941.

ORDER IN COUNCIL.

At the Government House at Wellington, this 23rd day of
July, 1941.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Poultry Act, 1924, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

1. These regulations may be cited as the Poultry Regulations 1941.
2. In these regulations, unless inconsistent with the context,—
“ The said Act ” means the Poultry Act, 1924 :
“ Inspector ” means an Inspector appointed under the said Act :
“ Owner ” includes the occupier of any premises in which poultry are kept or are exposed for sale or are held or stored, and also includes any person having charge of any poultry.
3. Any notice to be given by an Inspector to an owner of poultry pursuant to section 5 of the said Act shall be in the form numbered 1 in the Schedule hereto.
4. Any notice to be given by an Inspector to an owner of poultry pursuant to subsection (2) of section 7 of the said Act shall be in the form numbered 2 in the said Schedule.

POULTRY ACT, 1924, AND THE POULTRY REGULATIONS 1941.

PLEASE take notice that as a result of an inspection made on the day of of your premises situate at used for the (exposing for sale), (holding), (storing), or (keeping) of poultry—

- *(a) I find existing the following defects in the sanitary conditions required by the Poultry Act, 1924, to be maintained—namely,; (and)
- *(b) I find obtaining the following insanitary practice(s)—namely,; (and)
- *(c) I find that there is (are) in use the following insanitary appliance(s)—namely,

I therefore require you, in pursuance of section 5 of the said Act (within days after) (forthwith upon) service of this notice upon you—

- *(i) To remedy the said defects to my satisfaction; (and)
- *(ii) To abandon the said insanitary practice(s); (and)
- *(iii) To abandon the use of the said insanitary appliance(s); and
- *(iv) To remove upon the grounds specified above all poultry from (the said premises) (the following part of the said premises—namely,).

Failure or neglect to comply with this notice renders you liable on conviction to a fine of £20.

POULTRY ACT, 1924, AND THE POULTRY REGULATIONS 1941.

To

PLEASE take notice that as a result of an inspection carried out on the day of on the premises occupied (by you) (by) situated at I find certain poultry of which you are the owner to be diseased. (As to the meaning of the term "owner," see the note at the foot of this form.)

I therefore hereby direct you, in pursuance of the above-mentioned Act and regulations—

- *(a) Forthwith to kill by dislocation of the neck and within twenty-four hours thereafter to destroy by fire or burying all diseased poultry described in the First Schedule hereto; (and)
- *(b) Forthwith to kill by dislocation of the neck and within twenty-four hours thereafter to destroy by fire or burying all other poultry with which the diseased poultry have come into contact, in particular the poultry described in the Second Schedule hereto; (and)
- *(c) Not to remove from the said premises for a period of (months), (weeks), (days) from the date of the service upon you of this notice (except with the permission in writing of an Inspector and subject to such conditions as he thinks fit to impose)—
 - (i) Any eggs for hatching purposes produced on the said premises;
 - (ii) Any poultry at any age;
 (and)
- *(d) Forthwith to take the following other steps for the prevention of the spread of disease—namely:
