### THE PHARMACY REGULATIONS 1944, AMENDMENT NO. 1

# C. L. N. NEWALL, Governor-General ORDER IN COUNCIL

At the Government House at Wellington, this 29th day of August, 1945

### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Pharmacy Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and in accordance with recommendations made by the Pharmacy Board of New Zealand and transmitted by the Board to the Minister of Health, doth hereby make the following regulations.

#### REGULATIONS

- 1. These regulations may be cited as the Pharmacy Regulations 1944, Amendment No. 1, and shall be read together with and deemed part of the Pharmacy Regulations 1944\* (hereinafter referred to as the principal regulations).
- 2. Regulation 3 of the principal regulations is amended by inserting therein, next following the definition of "the Act", the following definition:
  - "'College of Pharmacy' means a school, college, or other institution maintained by the Pharmaceutical Society of New Zealand under section 24 of the Statutes Amendment Act. 1943."
- 3. Regulation 23 of the principal regulations is amended by revoking the words "each year", and substituting the words "the final year".
- 4. Regulation 29 of the principal regulations is amended by revoking the words "section 2", and substituting the words "subsection (2) of section 11".

- 5. Clause (2) of Regulation 36 of the principal regulations shall, on the 1st day of January, 1946, be revoked, and the following clause shall thereupon be substituted therefor:—
- "(2) (a) A candidate shall not present himself for the Section B Examination until he has—

"(i) Passed the Preliminary Examination; and

- "(ii) Commenced serving under articles of apprenticeship; and
- "(iii) Taken with a College of Pharmacy, either by correspondence or personal attendance, a course of study extending over a period of two years and commencing not earlier than the date on which he commenced to serve under articles of apprenticeship.
- "(b) A candidate shall not present himself for the Section C Examination until he has-

"(i) Passed the Section B Examination; and

- "(ii) Taken with a College of Pharmacy, either by correspondence or personal attendance, a course of study extending over a period of two years and commencing not earlier than the date on which he passed the Section B Examination:
- "Provided, first, that the Board shall grant exemption from the provisions of this clause that require a candidate to take a course of study with a College of Pharmacy in any case in which the Board is satisfied that the candidate has during his service under articles of apprenticeship received adequate tuition and training by personal attendance for such periods as the Board thinks necessary at some university college, technical school, or similar educational institution approved by the Board:

"Provided, secondly, that the Board may in its discretion grant exemption from any of the requirements of this clause in any other case, but subject to such conditions as it thinks fit to impose:

"Provided, thirdly, that the requirements of this clause are in addition to the requirements set out in Regulation 23 hereof."
