

THE PHARMACY REGULATIONS 1944, AMENDMENT NO. 20

DENIS BLUNDELL, Governor-General ORDER IN COUNCIL

At the Government Buildings at Wellington this 9th day of April 1973 Present:

THE HON. W. E. ROWLING PRESIDING IN COUNCIL

PURSUANT to the Pharmacy Act 1970, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Pharmacy Regulations 1944, Amendment No. 20, and shall be read together with and deemed part of the Pharmacy Regulations 1944* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 7th day after

the date of their notification in the Gazette.

- 2. Period of practical training—Regulation 33 of the principal regulations (as substituted by regulation 7 of the Pharmacy Regulations 1944, Amendment No. 15) is hereby amended by omitting the words "one year", and substituting the words "52 weeks".
- 3. Place of practical training—(1) Regulation 34 of the principal regulations (as substituted by regulation 7 of the Pharmacy Regulations 1944, Amendment No. 15) is hereby amended by inserting in subclause (1), after the words "of this regulation", the words "and to regulation 35 of these regulations".
- (2) Regulation 34 of the principal regulations (as so substituted, and as amended by regulation 2 (1) of the Pharmacy Regulations 1944, Amendment No. 16) is hereby further amended by omitting from paragraph (b) of subclause (1) the words, "other than a hospital transferred to the Hospital Board under section 7 of the Mental Health Act 1969."
- (3) The Pharmacy Regulations 1944, Amendment No. 16, are hereby consequentially amended by revoking subclause (1) of regulation 2.

- 4. Relationship between examination and practical training—The principal regulations are hereby further amended by revoking regulation 35 (as substituted by regulation 7 of the Pharmacy Regulations 1944, Amendment No. 15), and substituting the following regulation:
- "35. (1) The period of practical training shall not commence until after the date on which the applicant first completes 1 of the examinations prescribed by regulation 29 of these regulations. The date on which the applicant first completes 1 of those examinations shall hereinafter be referred to as the graduation date.
- "(2) Unless the Council otherwise approves in any particular case, the period of practical training shall commence not later than 1 year after the graduation date.
- "(3) At least 26 consecutive weeks of the period of practical training shall be served in 1 of the places referred to in paragraph (a), or paragraph (b), or paragraph (c) of subclause (1) of regulation 34

of these regulations.

- "(4) Unless the Council otherwise approves in any particular case, no period of less than 26 consecutive weeks of practical training in any 1 of the places referred to in subclause (1) of regulation 34 of these regulations shall be taken into account for the purposes of calculating the total period of practical training prescribed in regulation 33 of these regulations.
- "(5) Subject to subclauses (2) to (4) of this regulation, the period of practical training shall, except in circumstances specially approved by the Council, be completed within 2 years after the graduation date."
- 5. Saving—Notwithstanding anything in regulations 2 or 4 of these regulations, regulations 33 and 35 of the principal regulations (as substituted by regulation 7 of the Pharmacy Regulations 1944, Amendment No. 15) shall continue to apply in respect of any person who commenced, before the 1st day of April 1972, a course of education and training prescribed by regulation 29 of the principal regulations (as so substituted) as if the said regulations 2 and 4 had not been made.
- 6. Appeals—The principal regulations are hereby further amended by revoking the Sixth Schedule, and substituting the Schedule contained in the Schedule to these regulations.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Pharmacy Regulations 1944, and relate to the prescribed period of practical training required to be served by an applicant for registration as a pharmacist under the Pharmacy Act 1970. A saving clause is included. A new form is provided for giving notice of appeal against a decision of the Council of the Pharmaceutical Society.
