# THE POISONS (LICENSING) REGULATIONS 1951

# B. C. FREYBERG, Governor-General ORDER IN COUNCIL

At the Government Buildings at Wellington, this 13th day of March, 1951

### Present:

THE RIGHT HON, S. G. HOLLAND PRESIDING IN COUNCIL

PURSUANT to the Poisons Act, 1934, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

#### REGULATIONS

- 1. (1) These regulations may be cited as the Poisons (Licensing) Regulations 1951.
- (2) These regulations shall come into force on the 1st day of April, 1951.
  - 2. In these regulations, unless the context otherwise requires,—
    - "The Act" means the Poisons Act, 1934:
    - "Licence" means a storekeeper's poison licence, a wholesaler's poison licence, a wholesaler's poison licence for a Rabbit Board, or a storekeeper's extended poison licence.

### Application for Licence or Renewal of Licence

- 3. Every application for a licence or for the renewal of a licence shall be made in writing signed by or on behalf of the applicant, and in such one of the forms numbered 1 to 6 in the First Schedule hereto as may be appropriate. Every application shall refer to only one place of business.
- 4. In the case of persons carrying on business in partnership, a single application may be made on behalf of both or all of the partners, and a joint licence may be issued to those persons accordingly.
- 5. (1) Every application for a licence or for the renewal of a licence shall, after payment of the prescribed fee in accordance with subclause (4) of regulation 6 hereof, be delivered or sent by the applicant to:
  - (a) An Inspector of Health or an officer in charge of a police station; or
  - (b) The Medical Officer of Health for the district.
- (2) Where any such application is delivered or sent to an Inspector of Health or an officer of police as aforesaid, that Inspector or officer shall make thereon, in the prescribed manner, his recommendation with respect to the application, and shall forward the application to the Medical Officer of Health for the district.

#### FEES

6. (1) Subject to the provisions of subclause (2) of this regulation, the fees payable on any application for a licence shall be as follows:—

- (2) If at any time during the currency of a storekeeper's extended poison licence, the holder of the licence dies, or the Registrar, or any officer to whom the powers of the Registrar are delegated under the Act, is satisfied that by reason of any termination or alteration of employment or dissolution of partnership the holder is no longer authorized to sell poisons at the place of business stated in the licence, the fee payable on any application for another storekeeper's extended poison licence in respect of the same place of business, and upon the surrender to the Registrar or to such officer as aforesaid of the first mentioned licence, shall be 10s.
- (3) The fees payable on any application for a renewal of a licence shall be as follows:—

(4) All fees shall be paid to the Medical Officer of Health for the district.

### FORM OF LICENCE

7. Every licence shall be in such one of the forms numbered 7 to 9 in the First Schedule hereto as may be appropriate.

### STOREKEEPER'S EXTENDED POISON LICENCE

- 8. Every application for a storekeeper's extended poison licence or for a renewal thereof shall bear a certificate signed by a Justice of the Peace, or by some other responsible person approved by the Registrar or the officer to whom the Registrar's powers are delegated as aforesaid, to the effect of the certificate set out in the forms numbered 5 and 6 in the First Schedule hereto.
- 9. The poisons specified in the Second Schedule hereto shall be excluded from the operation of a storekeeper's extended poison licence, and accordingly a storekeeper's extended poison licence shall authorize the holder to sell only such poisons for the time being included in the First and Second Schedules to the Act as are not specified in the Second Schedule hereto.
- 10. The Poisons (Licensing) Regulations 1935\*, and subclause (4) of regulation 1 and regulation 10 of the Poisons (General) Regulations 1937† are hereby revoked.

(b) Its salts. Group II-(a) Barbituric acid;(b) Its salts; (c) Derivatives of barbituric acid; (d) Their salts; (e) Compounds with any other substance of barbituric acid or of its salts or of its derivatives or of their salts. Group III-(a) Dinitrocresols; (b) Dinitronaphthols;
(c) Dinitrophenols; (d) Dinitrothymols. Group IV-(a) Phenyleinchoninic acid;(b) Its salts; (c) Its esters; (d) Salicyleinehoninic acid; (e) Its salts; (f) Its esters. Group V-(a) Sulphonal; (b) Alkyl sulphonals. Group VI-Chlorodyne and similar substances containing more than 0.1 per cent of morphine and less than 0.2 per cent of morphine. Group VII-(a) Para-aminobenzene sulphonamide;

- (b) Its salts; (c) Derivatives of para-aminobenzene sulphonamide having another radical or radicals substituted for one or both of the hydrogen atoms of-
  - (i) The para-amino group, or
  - (ii) The sulphonamide group, or (iii) Both of these groups;
- (d) The salts of such derivatives.

(a) Ergot;

### EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations consolidate and amend the Poisons (Licensing) Regulations 1935. The changes made by these regulations are set out below.

- l. Fees (except in the case of storekeepers' extended poison licences) are increased as follows :—
  - (a) Licences: Storekeepers' licences, from 3s. 6d. to 5s.; wholesalers' licences from 3s. 6d. to 10s.:
  - (b) Renewals: Storekeepers' licences, from 2s. 6d. to 5s.; wholesalers' licences, from 2s. 6d. to 10s.
- 2. Fees are to be paid to the Medical Officer of Health for the district instead of to the Post Office.
- 3. The issue and renewal of licences may now be completed in district offices of the Health Department.
- 4. The list of poisons excluded from the operation of a storekeeper's extended poison licence has been completely revised (Second Schedule).
