THE PLUMBERS REGULATIONS 1951, AMENDMENT NO. 6

COBHAM, Governor-General

ORDER IN COUNCIL

At the Government House at Wellington this 19th day of July 1961

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Plumbers Registration Act 1953, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Plumbers Regulations 1951, Amendment No. 6, and shall be read together with and deemed part of the Plumbers Regulations 1951* (hereinafter referred to as the principal regulations).

(2) Regulations 1 and 2 and the First Schedule to these regulations shall come into force on the day after the date of their notification in the *Gazette*, and the remaining provisions of these regulations shall come into force on the day six months and one day after that day.

2. The districts and localities mentioned in the First Schedule to these regulations are hereby declared to be districts and localities within which, on and after the expiry of six months from the date of the coming into force of this regulation, all sanitary plumbing shall be done by registered plumbers.

3. The principal regulations are hereby amended by revoking the Third Schedule as heretofore amended, and substituting the Third Schedule set out in the Second Schedule to these regulations.
