THE PHYSIOTHERAPY REGULATIONS 1953, AMENDMENT NO. 3

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Physiotherapy Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Physiotherapy Regulations 1953, Amendment No. 3, and shall be read together with and deemed part of the Physiotherapy Regulations 1953* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of October 1968.
- 2. Fees—(1) Regulation 16 of the principal regulations (as amended by regulation 4 of the Physiotherapy Regulations 1953, Amendment No. 1, and by regulation 3 of the Physiotherapy Regulations 1953, Amendment No. 2) is hereby further amended by revoking subclause (1), and substituting the following subclause:
- "(1) There shall be payable by every applicant for admission to Part I of the State Examination a fee of \$25 and by every applicant for admission to Part II of the State Examination a fee of \$20."
- (2) Regulation 16 of the principal regulations (as so amended and as amended by section 7 (1) of the Decimal Currency Act 1964) is hereby further amended—
 - (a) By omitting from subclause (2) the expression "\$3.50" in each place where it occurs, and substituting in each case the expression "\$6.50":
 - (b) By omitting from subclause (3) the expression "\$6", and substituting the expression "\$10":

*S.R. 1953/151 Amendment No. 1: S.R. 1961/143 Amendment No. 2: S.R. 1966/6 (c) By omitting from subclauses (4), (5), and (6) the expression "\$1" in each place where it occurs, and substituting in each case the expression "\$3":

(d) By revoking subclause (7).

(3) Notwithstanding the amendment made to regulation 16 of the principal regulations by paragraph (c) of subclause (2) of this regulation the fee payable by any physiotherapist for the issue of an annual practising certificate in respect of the year beginning on the 1st day of April 1968 shall be \$1.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Physiotherapy Regulations 1953 by increasing the fee payable by an applicant for registration as a physiotherapist from \$6 to \$10 and the fee for the issue of a certificate of registration from \$1 to \$3. The fee payable for the restoration of a name to the register and the fee payable for the issue of an annual practising certificate are each also increased from \$1 to \$3. Fees payable in respect of the State Examination in Physiotherapy are increased from \$3.50 payable in respect of each subsection of the examination to \$25 for admission to Part I and \$20 for admission to Part II of the examination. The fee for re-examination is increased from \$3.50 to \$6.50 for each subsection in which the applicant is re-examined. The new fees come into force on 1 October 1968 but the fee payable for the issue of a practising certificate for the year that commenced with 1 April 1968 is not affected.
