Pursuant to the Poisons Act 1960, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Poisons Regulations 1964, Amendment No. 12, and shall be read together with and deemed part of the Poisons Regulations 1964* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 28th day after the date of their notification in the Gazette.
- 2. Interpretation—(1) Regulation 2 (1) of the principal regulations is hereby amended by revoking the definition of the term "commercial user", and substituting the following definition:
 "'Commercial user' means a person who—

- "(a) Regularly uses land for the purposes of—
 - "(i) Any agricultural, horticultural, pastoral, or recreational undertaking carried on for profit; or
- "(ii) The keeping of animals, bees, or birds for profit and requires a poison in connection with any such use; or
- "(b) Requires a poison for use in any scientific, educational, or commercial laboratory; or
- "(c) Requires a poison for use in any manufacturing process, or in connection with any trade or business; or
- "(d) Requires a poison for use in any public reserve, within the meaning of the Reserves and Domains Act 1953, or other public recreational area, that he is responsible for maintaining."
- (2) Regulation 2 of the Poisons Regulations 1964, Amendment No. 2 is hereby consequentially revoked.
- 3. Exemptions—Regulation 9 of the principal regulations is hereby amended by revoking subclause (5), and substituting the following subclause:
- "(5) The provisions of these regulations shall not apply to any seeds dressed with a poison or poisonous substance if the container in which the dressed seeds are enclosed or contained bears a label conspicuously printed with the words 'Treated seed. Not to be used for human or animal consumption."
- 4. Use of dieldrin in processing of timber products—Regulation 11A of the principal regulations (as inserted by regulation 4 of the Poisons Regulations 1964, Amendment No. 9) is hereby amended by omitting from subclause (2) (d) the words "to the extent that dieldrin is incorporated in glue used in such processing".

5. Conditions under which medical practitioners and dentists may prescribe prescription poisons—(1) Regulation 16 of the principal regulations is hereby amended by adding to subclause (1) the words ", unless the medical practitioner is acting in the course of his employment in the service of the Crown".

(2) The said regulation 16 is hereby further amended by revoking

subclause (2), and substituting the following subclause:

"(2) No dentist shall prescribe any prescription poison otherwise than for the dental treatment of a patient under his care, and no dentist shall prescribe for any patient a quantity of any prescription poison exceeding 5 days' supply, or, if the prescription provides for a repeat for consecutive days, exceeding 7 days' supply in the aggregate."

(3) Regulation 5 of the Poisons Regulations 1964, Amendment No. 3

is hereby consequentially repealed.

- 6. Sale of para-aminobenzene sulphonamide without prescription—Regulation 18 of the principal regulations is hereby revoked.
- 7. Prescription not required in certain cases—(1) Regulation 20 of the principal regulations is hereby amended by inserting, after paragraph (d), the following paragraph:

"(da) A person for inclusion in an emergency medical kit kept or to be kept for use in any vessel to which paragraph (d) of this regulation does not apply, and is so sold or dispensed pursuant to an order signed by a District Registrar; or".

(2) The said regulation 20 is hereby further amended by adding to paragraph (1) the word "or"; and also by adding the following

paragraph:

"(m) A person who has previously been supplied with the poison on the prescription of a medical practitioner for a particular condition, and is so sold or dispensed—

"(i) By a pharmacist who is satisfied that that person requires an emergency supply of the poison for that condition;

and

- "(ii) In an amount not exceeding the quantity reasonably required by that person for a period of 72 hours."
- 8. Containers—Regulation 29 of the principal regulations is hereby amended by revoking subclause (9), and substituting the following subclause:
- "(9) No person shall use, whether temporarily or permanently, for the storage of any poison or poisonous substance, any bottle, jar, tin, tinplate container, culinary utensil, or other receptacle that—

"(a) Bears any brand, mark, statement, or picture—

- "(i) Purporting to indicate the presence in the container of any food, drink, condiment, or medicine intended for internal use; or
- "(ii) That is likely to lead any person to believe that the contents of the container are intended for human consumption; or
- "(b) Whether or not it bears any brand, mark, statement, or picture, is of a distinctive type in which any food, drink, condiment, or medicine intended for internal use has been commonly or is being currently sold."

- 9. Labelling on containers of certain hair dyes, etc.—Regulation 44 of the principal regulations is hereby amended by omitting from paragraph (c) the words "and should be used only in accordance with expert advice".
- 10. Labelling on containers of noxious substances—Regulation 49 of the principal regulations is hereby amended by omitting the words "poison or poisonous substance", and substituting the words "restricted poison".
- 11. Records—(1) Regulation 58 of the principal regulations (as amended by regulation 7 of the Poisons Regulations 1964, Amendment No. 3) is hereby amended—
 - (a) By omitting from paragraph (c) the words "for internal use":
 - (b) By revoking paragraph (d).
- (2) Regulation 7 of the Poisons Regulations 1964, Amendment No. 3 is hereby consequentially revoked.
- 12. New First Schedule poisons—(1) The substances named in the First Schedule to these regulations are hereby declared to be poisons.
- (2) The First Schedule to the principal regulations (as amended from time to time) is hereby further amended by inserting, in their appropriate alphabetical order, the names of the substances declared to be poisons by subclause (1) of this regulation.

- (s) By omitting from the item that begins with the word "Diquat", the words "(1:1'-ethylene-2:2'-dipyridylium dibromide)":
- (t) By omitting from the item that begins with the word "Fenitrothion" (as inserted by regulation 7 of the Poisons Regulations 1964, Amendment No. 2) the words "(0,0-dimethyl 0-(3 methyl-4-nitro-phenyl) phosphorothioate":
- (u) By omitting the item "1,4,5,6,7,8,8-heptachloro-3a,4,6,6a-tetra-hydro-4,7 methanoindene (Heptachlor)", and inserting, in its appropriate alphabetical order, the item "Heptachlor":
- (v) By omitting the item "6,7,8,7,10,10-hexachloro-1,5,5a,6,9,9a-hexahydro-6,9-methano-2,4,3-benzodioxathiepin-3-oxide (Thiodan)", and inserting, in its appropriate alphabetical order, the item "Endosulfan":
- (w) By omitting the item "Isosorbide; its salts" (as inserted by regulation 9 of the Poisons Regulations 1964, Amendment No. 9), and inserting, in its appropriate alphabetical order, the item "Sorbide; its salts":

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Poisons Regulations 1964.

Regulation 1 relates to the Title and commencement.

Regulations 2 to 4 relax certain requirements of the principal regulations to

facilitate commercial usage.

Regulation 5 relates to the prescribing of prescription poisons by medical practitioners. At present, regulation 16 (1) of the principal regulations prohibits a medical practitioner from prescribing such a poison otherwise than for the treatment of a patient under his care. The amendment exempts from this prohibition a medical practitioner in the course of his employment by the Crown.

This regulation (subclause (2)) also allows dentists to give repeat prescriptions.

Regulation 6 revokes regulation 18 of the principal regulations which imposed restrictions on the sale of para-aminobenzene sulphonamide without prescription. Regulation 18 is inconsistent with the relevant provisions of the Animal Remedies Act 1967.

Regulation 7 extends the circumstances in which a pharmacist may dispense

or sell a prescription poison without prescription in cases of emergency.

Regulation 8 clarifies the present provisions of regulation 29 (9) of the principal regulations relating to the use of containers for the storage of poisons and poisonous substances.

Regulation 9 alters the labelling requirements in respect of certain hair dyes, etc., containing any of the substances specified in regulation 44 of the principal

regulations.

Regulation 10 amends regulation 49 of the principal regulations which requires a container that contains a poison or poisonous substance to which the provisions of the Noxious Substances Regulations 1954 apply to be labelled with a statement to that effect. By virtue of this amendment, this requirement will

Regulation 11 requires records to be kept of sales of all First Schedule poisons, whether for internal or external use. At present, sales by retail of such poisons for external use are not subject to such a requirement. The regulation also removes the present requirement to keep records of sales of Second Schedule poisons.

Regulations 12 to 22 make miscellaneous changes to the Schedules to the principal regulations. Among these are changes in nomenclature whereby the chemical names of some poisons have been removed and their recognised nonproprietary names have been substituted.
