# THE PHARMACY REGULATIONS 1975, AMENDMENT NO. 10

# HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 57 of the Pharmacy Act 1970, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and on the advice of the Minister of Health, given after consultation by the Minister of Health with the Council of the Pharmaceutical Society of New Zealand, hereby makes the following regulations.

### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Pharmacy Regulations 1975, Amendment No. 10, and shall be read together with and deemed part of the Pharmacy Regulations 1975\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of January 1994.

2. Annual practising fee—The principal regulations are hereby amended by revoking regulation 26 (as substituted by regulation 2 of the Pharmacy Regulations 1975, Amendment No. 8), and substituting the following regulation:

following regulation: "26. (1) Subject to subclauses (2) to (4) of this regulation, every pharmacist shall pay to the Society an annual practising fee of \$250.00. "(2) A pharmacist who satisfies the Registrar that he or she is not

"(2) A pharmacist who satisfies the Registrar that he or she is not resident in New Zealand shall be required to pay an annual practising fee of only \$144.68.

"(3) A pharmacist who satisfies the Registrar-

"(a) That the pharmacist has attained the age of 65 years (but has not attained the age of 70 years); or

"(b) That the pharmacist is no longer substantially engaged in pharmaceutical practice,—

shall be required to pay an annual practising fee of only \$125.00.

"(4) A pharmacist who satisfies the Registrar that the pharmacist has attained the age of 70 years shall be required to pay an annual practising fee of only 13.15."

**3. Revocation**—The Pharmacy Regulations 1975, Amendment No. 8 are hereby consequentially revoked.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 January 1994, increase the annual practising fees payable by pharmacists. The ordinary annual practising fee payable by a pharmacist is increased from \$238.50 to

The ordinary annual practising fee payable by a pharmacist is increased from \$238.50 to \$250.00.

The annual practising fee payable by a pharmacist who is not resident in New Zealand is increased from \$137.98 to \$144.68.

The annual practising fee payable by a pharmacist-

(a) Who has attained the age of 65 years but who has not attained the age of 70 years; or (b) Who is no longer substantially engaged in pharmaceutical practice,—

is increased from \$119.25 to \$125.00.

The annual practising fee payable by a pharmacist who has attained the age of 70 years is increased from 12.55 to 13.15.

The fees prescribed are inclusive of goods and services tax.
