

# THE PHARMACY REGULATIONS 1975, AMENDMENT NO. 7

## ORDER IN COUNCIL

At Wellington this 4th day of December 1989

#### Present:

THE RIGHT HON. G. W. R. PALMER PRESIDING IN COUNCIL

PURSUANT to section 57 of the Pharmacy Act 1970, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Pharmacy Regulations 1975, Amendment No. 7, and shall be read together with and deemed part of the Pharmacy Regulations 1975\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of January
- 2. Fees inclusive of goods and services tax—The principal regulations are hereby amended by inserting, after regulation 3, the following regulation:

"3A. The fees prescribed by these regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985."

**3. Annual practising fee**—The principal regulations are hereby amended by revoking regulation 26 (as substituted by regulation 2 of the Pharmacy Regulations 1975, Amendment No. 5), and substituting the following regulation:

"26. (1) Subject to subclauses (2) to (4) of this regulation, every

pharmacist shall pay to the Society an annual practising fee of \$213.75.

"(2) A pharmacist who satisfies the Registrar that he or she is not resident in New Zealand shall be required to pay an annual practising fee of only \$123.75.

"(3) A pharmacist who satisfies the Registrar—

- "(a) That he or she has attained the age of 65 years (but has not attained the age of 70 years); or
- "(b) That he or she is no longer substantially engaged in pharmaceutical practice-

shall be required to pay an annual practising fee of only \$106.88.

- "(4) A pharmacist who satisfies the Registrar that he or she has attained the age of 70 years shall be required to pay an annual practising fee of only **\$**11.25."
- 4. New First Schedule (relating to fees) substituted—The principal regulations are hereby amended by revoking the First Schedule (as substituted by regulation 3 of the Pharmacy Regulations 1975, Amendment No. 2, and amended by regulation 3 of the Pharmacy Regulations 1975, Amendment No. 3), and substituting the First Schedule set out in the Schedule to these regulations.
- **5. Revocations**—The following regulations are hereby consequentially revoked:

## **EXPLANATORY NOTE**

This note is not part of the regulations, but is intended to indicate their general effect.

5. For a duplicate of any certificate issued by the Council

These regulations, which come into force on 1 January 1990, amend the Pharmacy Regulations 1975.

Regulation 2 inserts a new regulation 3A in the principal regulations. The new regulation states that the fees prescribed by the principal regulations are inclusive of goods and services tax.

Regulation 3 increases the ordinary and concessionary fees payable for practising certificates, except the concessionary fee for pharmacists who have attained the age of 70 years. That remains at \$11.25 (inclusive of goods and services tax).

Regulation 4 alters the fees prescribed by the First Schedule to the principal regulations (which relates to certain administration fees relating to the registration of pharmacists) so that they are now stated as including goods and services tax. There is no actual increase in those fees.

Regulation 5 is of a consequential nature only.
