



**THE PHYSIOTHERAPY REGULATIONS 1979,  
AMENDMENT NO. 2**

**ORDER IN COUNCIL**

At the Government Buildings at Wellington this 10th day of June 1985

Present:

THE RIGHT HON. DAVID LANGE PRESIDING IN COUNCIL

PURSUANT to section 31 of the Physiotherapy Act 1949, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

**1. Title and commencement**—(1) These regulations may be cited as the Physiotherapy Regulations 1979, Amendment No. 2, and shall be read together with and deemed part of the Physiotherapy Regulations 1979\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of July 1985.

**2. State Examination in Physiotherapy**—(1) Regulation 7 of the principal regulations is hereby amended by omitting from subclause (1) the words “and in the subjects”.

(2) Regulation 7 of the principal regulations is hereby further amended by inserting, after subclause (4), the following subclause:

“(4A) The Board may decline to accept any application that is not received within the period specified or allowed under subclause (4) of this regulation, and the person making any such application shall not be entitled to sit the State Examination on that occasion, notwithstanding that the person may be eligible under subclause (3) of this regulation to sit the examination.”

**3. Fees**—(1) The principal regulations are hereby amended by revoking regulation 17, and substituting the following regulation:

“17. (1) The fee for admission to the State Examination for any student physiotherapist sitting the full examination shall be \$40.

“(2) The fee for admission to the State Examination for any student physiotherapist whom the Board has directed need not sit the full examination shall be \$25.

“(3) The fee payable on an application for registration shall be \$45.

“(4) The fee for the issue of a certificate of registration shall be \$5.

“(5) The fee for the issuing of an annual practising certificate shall be \$30.

“(6) The fee for the restoration of a name to the register, pursuant to an application under section 16 (4) of the Act, shall be \$25.

“(7) The fee for a certificate of temporary registration shall be \$25.

“(8) The fee for the correction of a name in the register, pursuant to an application under section 18 (2) of the Act (not being a case to which the proviso to that subsection applies), shall be \$5.”

(2) Notwithstanding the provisions of regulation 17 (5) of the principal regulations (as substituted by subclause (1) of this regulation), the fee for the issue of a practising certificate in respect of the year ending with the 31st day of March 1986 shall be \$16.

**4. Revocation**—The Physiotherapy Regulations 1979, Amendment No. 1 are hereby consequentially revoked.

#### EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 1 July 1985, amend the Physiotherapy Regulations 1979.

*Regulation 2* removes a reference to subjects of the State Examination in Physiotherapy that is not appropriate, and empowers the Physiotherapy Board to prevent a person who is eligible to sit the State Examination from doing so if the application to sit the examination is not received at least 6 weeks before the date of the examination, or within such shorter period as the Board may allow.

*Regulation 3* increases the fees payable in respect of various matters under the principal regulations. Despite the increases, the fee for an annual practising certificate in respect of the year ending 31 March 1986 remains at \$16, which is the fee that was payable before these regulations came into force.
