

# THE PHYSIOTHERAPY REGULATIONS 1979, AMENDMENT NO. 9

#### ORDER IN COUNCIL

## HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 31(2)(e) of the Physiotherapy Act 1949, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Physiotherapy Regulations 1979, Amendment No. 9, and shall be read together with and deemed part of the Physiotherapy Regulations 1979\* (hereinafter referred to as the principal regulations).
  - (2) These regulations shall come into force on the 1st day of April 1994.
- 2. Fees—The principal regulations are hereby amended by revoking regulation 17 (as substituted by regulation 2 of the Physiotherapy Regulations 1979, Amendment No. 8), and substituting the following regulation:

"17. (1) The fee for admission to the State Examination for any student

physiotherapist sitting the full examination shall be \$500.00.

"(2) The fee for admission to the State Examination for any student physiotherapist whom the Board has directed need not sit the full examination shall be \$250.00.

"(3) The fee payable on an application for a re-count in respect of the

State Examination shall be \$30.00.

- "(4) The fee payable on an application for registration shall be \$140.00. "(5) The fee for the issue of a certificate of registration shall be \$30.00.
- "(6) The fee for the issue of an annual practising certificate shall be \$110.00.

"(7) The fee for the restoration of a name to the register, pursuant to an

application under section 16 (4) of the Act, shall be \$52.00.

t'(8) The fee for amending the register to add further qualifications, pursuant to an application under section 14 (1) of the Act, shall be \$52.00.

"(9) The fee for a certificate of temporary registration shall be \$140.00. "(10) The fee for the correction of a name in the register, pursuant to an application under section 18 (2) of the Act (not being a case to which the proviso to that subsection applies), shall be \$12.00.

"(11) The fee for supplying any document for the purpose of enabling a physiotherapist to seek registration outside New Zealand shall be \$30.00."

- **3. Fees inclusive of goods and services tax**—The fees fixed by these regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.
- **4. Revocation**—The Physiotherapy Regulations 1979, Amendment No. 8 are hereby consequentially revoked.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 1994, prescribe a new and increased scale of fees payable under the Physiotherapy Act 1949.

The fees prescribed are inclusive of goods and services tax.
