HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 18 of the Passports Act 1980, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Passport Regulations 1981, Amendment No. 3, and shall be read together with and deemed part of the Passport Regulations 1981* (hereinafter referred to as the principal regulations).
 - (2) These regulations shall come into force on the 29th day of July 1988.
- 2. New scale of fees substituted—The principal regulations are hereby amended by revoking the Schedule (as substituted by regulation 2 of the Passport Regulations 1981, Amendment No. 2), and substituting the Schedule set out in the Schedule to these regulations.
- **3. Fees inclusive of goods and services tax**—The fees fixed by regulation 2 of these regulations are inclusive of goods and services tax payable under the Goods and Services Tax Act 1985.
- **4. Revocation**—The Passport Regulations 1981, Amendment No. 2 are hereby consequentially revoked.
