# THE PESTICIDES REGULATIONS 1983, AMENDMENT NO. 3

#### ORDER IN COUNCIL

At Wellington this 20th day of July 1987

#### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 76 of the Pesticides Act 1979, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Pesticides Regulations 1983, Amendment No. 3, and shall be read together with and deemed part of the Pesticides Regulations 1983\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 28th day after the date of their notification in the Gazette.
- 2. Two new regulations (relating to fees) inserted in principal regulations—The principal regulations are hereby amended by inserting, after regulation 3, the following regulations:
- "3A. Annual registration fee—(1) Subject to the succeeding provisions of this section, for each year during which a pesticide remains registered under the Act there shall be payable a fee of \$270.

"(2) No fee shall be payable under this regulation for the first year in which the pesticide is registered.

"(3) Every such fee shall be payable within 1 month after the Board gives

written notice to the proprietor requiring payment of the fee.

- "(4) No fee shall be payable under this regulation where, within the period of 1 month referred to in subclause (3) of this regulation, the proprietor applies to the Board for cancellation of the registration of the pesticide.
- "3B. Fee for authority to import for own use—(1) The fee payable on application to the Board under section 21 (2) of the Act for authority to import a pesticide for use by the proprietor on land owned or occupied by the proprietor shall be \$55.
  - "(2) Where such an application is made by 2 or more proprietors of the

same pesticide, each of these proprietors shall be liable to pay—

"(a) An equal share of the fee prescribed by subclause (1) of this regulation; and

"(b) A further fee of \$5.

- "(3) Where an application is made in respect of 2 or more pesticides, or in respect of importation on 2 or more occasions, the fee prescribed by subclause (1) of this regulation shall be payable in respect of each pesticide and in respect of each occasion.
- "(4) The fees fixed by this regulation are inclusive of goods and services tax under the Goods and Services Tax Act 1985."

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations prescribe certain fees, following enactment of the Pesticides Amendment Act 1987. An annual registration fee of \$270 is prescribed, but will not be payable if registration is surrendered within 1 month of the fee being demanded. In addition, a basic fee of \$55 is prescribed where the Pesticides Board's authority is sought for the importation of a pesticide for use by the proprietor on his or her own land.
