



## THE PSYCHOLOGISTS REGULATIONS 1983, AMENDMENT NO. 4

### ORDER IN COUNCIL

At Wellington this 12th day of March 1990

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 43 (a) of the Psychologists Act 1981, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and on the advice of the Minister of Health given after consultation with the Psychologists Board, hereby makes the following regulations.

### REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Psychologists Regulations 1983, Amendment No. 4, and shall be read together with and deemed part of the Psychologists Regulations 1983\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1990.

**2. Fees**—The principal regulations are hereby amended by revoking regulation 3 (as substituted by regulation 2 of the Psychologists

Regulations 1983, Amendment No. 3), and substituting the following regulation:

“(1) The fee payable in respect of an application for registration under section 15 of the Act shall be \$68.00.

“(2) The fee for the issue of a certificate of registration under section 18 of the Act shall be \$24.00.

“(3) The fee for the issue of a certificate of temporary registration under section 23 of the Act shall be \$56.00.

“(4) The fee for the issue of an annual practising certificate under section 25 of the Act shall be \$68.00.

“(5) The fee for the issue of a copy of a certificate of registration shall be \$24.00.

“(6) The fee for supplying to a psychologist any document for the purpose of seeking registration overseas shall be \$24.00.”

**3. Fees inclusive of goods and services tax**—The fees fixed by these regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.

**4. Revocation**—The Psychologists Regulations 1983, Amendment No. 3 are hereby consequentially revoked.

EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 1 April 1990, prescribe a new and increased scale of fees payable under the Psychologists Act 1982.

The fees prescribed are inclusive of goods and services tax.
