# THE PESTICIDES (FEES) REGULATIONS 1993

### ORDER IN COUNCIL

At Wellington this 14th day of June 1993

#### Present:

HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 76 of the Pesticides Act 1979, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

# REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Pesticides (Fees) Regulations 1993.
  - (2) These regulations shall come into force on the 1st day of July 1993.
- **2. Interpretation**—In these regulations, unless the context otherwise requires,—
  - "The Act" means the Pesticides Act 1979:
  - "Registration year" means a period of 12 months commencing on the 1st day of July in any year.
- **3. Importation fee**—There is hereby prescribed for the purposes of section 21 (3) of the Act (which relates to the fee payable in respect of applications for authority to import pesticides for use by their proprietors) a fee of—
  - (a) \$55, where the application is made by a single proprietor; and

- (b) \$60 (payable in such proportions as the proprietors decide), where the application is made by 2 or more proprietors,—for each importation of each pesticide.
- **4. Application fee**—There is hereby prescribed for the purposes of section 22 (2) (a) of the Act (which relates to the fee payable in respect of an application for the registration of a pesticide) a fee of \$2,250.
- 5. Annual fee—The proprietor of a pesticide registered under the Act before the 1st day of July in any registration year shall, on or before the 31st day of July in that year, pay in respect of its continued registration in that year a fee of \$499.50, unless—
  - (a) It ceased to be so registered before that 1st day of July; or
  - (b) Its proprietor has, before that 31st day of July, applied to the Board for the cancellation of its registration under the Act.
- **6. Goods and services tax included**—The fees prescribed by these regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.
- **7. Consequential revocations**—The following regulations are hereby consequentially revoked:
  - (a) Regulations 3 to 4 of the Pesticides Regulations 1983:
  - (b) The Pesticides Regulations 1983, Amendment No. 3:
  - (c) The Pesticides Regulations 1983, Amendment No. 4:
  - (d) The Pesticides Regulations 1983, Amendment No. 5.

### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 July 1993, prescribe fees for the purposes of the Pesticides Act 1979. The fees for applications for authority to import pesticides for use by their proprietors are unchanged. The fee payable in respect of an application for the registration of a pesticide is increased from \$1,687.50 to \$2,250. The annual fee for the registration of a pesticide is increased from \$393.75 to \$499.50. All fees are inclusive of GST.
