**THE PHARMACY REGISTRATION REGULATIONS 1955,  
AMENDMENT NO. 2**

**ORDER IN COUNCIL**

At the Government Buildings at Wellington this 5th day of February 1968

Present:

THE RIGHT HON. KEITH HOLYOAKE, C.H., PRESIDING IN COUNCIL

PURSUANT to the Pharmacy Act 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

---

**REGULATIONS**

**1. Title and commencement**—(1) These regulations may be cited as the Pharmacy Registration Regulations 1955, Amendment No. 2, and shall be read together with and deemed part of the Pharmacy Registration Regulations 1955\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

**2. Application to register pharmacy**—The principal regulations are hereby amended by revoking regulation 5, and substituting the following regulation:

“5. (1) Every proprietor of a pharmacy shall, in accordance with these regulations, apply to the Registrar for the registration of the pharmacy.

“(2) The application shall be in writing, in form 1 in the Schedule hereto, and shall contain the particulars therein set out.”

**3. Renewal of registration**—Regulation 7 of the principal regulations is hereby amended by adding to subclause (3) the words “The application for renewal shall be in form 1 in the Schedule hereto, shall contain the particulars therein set out, and shall be accompanied by a statutory declaration verifying the truth of the statements contained in the application.”

**4. Time of application**—The principal regulations are hereby further amended by revoking regulation 9, and substituting the following regulation:

“9. (1) Every application to register a pharmacy shall be made not later than 21 days before the date on which it is proposed to commence business in the pharmacy.

“(2) Every application for renewal of registration shall be made not later than the 30th day of June in each year.”

**5. Form of application to register or reregister pharmacy**—The Schedule to the principal regulations is hereby amended by revoking form 1, and substituting the form set out in the Schedule to these regulations.

#### APPLICATION FOR REGISTRATION OR RENEWAL OF REGISTRATION OF A PHARMACY

To the Registrar of the Pharmacy Board.

APPLICATION is hereby made for the registration or renewal of registration of a pharmacy, the particulars of which are set out hereunder:

1. PROPRIETOR—If the proprietor of the pharmacy is—

3. COMMENCEMENT OF BUSINESS—The date on which the present proprietor became the proprietor of this pharmacy (if prior to 1 October 1954 it is sufficient to state that fact): .....

4. ENROLLED MANAGER—The name of the enrolled manager (if any) of the pharmacy: .....

5. CONSENT OF PHARMACY AUTHORITY—If the pharmacy is established or carried on with the consent of the Pharmacy Authority, the date of the consent and particulars of any conditions prescribed by the Authority: .....

## 6. OTHER INTERESTS IN THE PHARMACY—

[NOTE—‘Interest’ includes direct and indirect interests, whether by way of shares in a company or by way of charge, loan, guarantee, indemnity, or otherwise.]

- (a) Does the proprietor of any other pharmacy have an interest in this pharmacy? If so give full particulars. (If the pharmacy is an urgent pharmacy it is sufficient to state that fact): .....
- (b) Does any wholesale dealer in drugs have any interest in this pharmacy? If so give full particulars: .....
- (c) [If the proprietor of the pharmacy is a company.] Does any person who is not a member of the company have any interest in any of the shares of the company? If so give his full name and address and particulars of his interest: .....

## EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

Regulation 2 requires particulars of direct and indirect interests in pharmacies to be disclosed on the form of application for registration.

Regulation 3 provides that application for renewal of registration is to be made in the same form as an original application.

Regulation 4 requires every application for registration of a new pharmacy to be made not later than 21 days before the proposed date of commencement of business, instead of 14 days after commencement as at present.

Regulation 5 amends the form of application for registration of a pharmacy to conform to the changes made by regulations 2 and 4.
