THE PARLIAMENTARY SALARIES AND ALLOWANCES ORDER 1951

At the Government House at Wellington, this 24th day of October 1951

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to section 27 of the Civil List Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and in accordance with the recommendations of a Royal Commission appointed in that behalf, as set out in the report laid before Parliament as parliamentary paper H–25 of 1951, hereby makes the following order.

ORDER

- 1. (1) This order may be cited as the Parliamentary Salaries and Allowances Order 1951.
- (2) This order shall be deemed to have come into force on the 1st day of September 1951.

EXECUTIVE

- 2. There shall be paid to the Prime Minister-
- (a) A salary at the rate of £3,000 a year; and
- (b) An allowance to provide for expenses incurred in connection with his official and parliamentary duties at the rate of £1,000 a year.
- 3. There shall be paid to each Minister of the Crown holding a portfolio or portfolios (other than the Prime Minister)—
 - (a) A salary at the rate of £2,000 a year; and
 - (b) An allowance to provide for expenses incurred in connection with his official and parliamentary duties, at the rate of £450 a year, or, in the case of the Minister of External Affairs, at the rate of £600 a year.
- ${\bf 4.}$ There shall be paid to each Minister of the Crown without portfolio—
 - (a) A salary at the rate of £1,650 a year; and
 - (b) An allowance to provide for expenses incurred in connection with his official and parliamentary duties, at the rate of £400 a year.
 - 5. There shall be paid to each Parliamentary Under-Secretary—
 - (a) A salary at the rate of £1,250 a year; and
 - (b) An allowance to provide for expenses incurred in connection with his official and parliamentary duties, at the rate of £350 a year.

- 6. There shall be paid to each Minister of the Crown and to each Parliamentary Under-Secretary an allowance of £3 3s. for every day on which he is travelling within New Zealand on public service.
- 7. There shall be paid to each Minister of the Crown or Parliamentary Under-Secretary who is not provided at the public cost with a residence at the seat of Government a house allowance at the rate of £300 a year.

Officers of the House

- $\bf 8. \ There$ shall be paid to the Speaker of the House of Representatives—
 - (a) A salary at the rate of £1,600 a year; and
 - (b) An allowance to provide for expenses incurred in connection with his official and parliamentary duties, at the rate of $\pounds 500$ a year.
- **9.** There shall be paid to the Chairman of Committees of the House of Representatives—
 - (a) A salary at the rate of £1,300 a year; and
 - (b) An allowance to provide for expenses incurred in connection with his official and parliamentary duties, at the rate of £350 a year.

LEADER OF THE OPPOSITION

- 10. There shall be paid to the member of the House of Representatives who is for the time being leader of the Official Opposition—
 - (a) A salary at the rate of £1,600 a year; and
 - (b) An allowance to provide for expenses incurred in connection with his official and parliamentary duties, at the rate of £400 a year; and
 - (c) An allowance to provide for expenses incurred in travelling outside his electorate in connection with his official duties, at the rate of £150 a year.

MEMBERS

- 11. (1) There shall be paid to each member of the House of Representatives to whom the foregoing provisions of this order do not apply—
 - (a) A salary at the rate of £900 a year; and
 - (b) An allowance to provide for expenses incurred in connection with his parliamentary duties, at the appropriate rate specified in subclause (2) of this clause.
 - (2) The rate of the allowance under this clause shall be—
 - (a) In the case of a member for a Wellington electorate, £250 a year:
 - (b) In the case of a member for an urban electorate other than a Wellington electorate, £400 a year:
 - (c) In the case of a member for a partly rural electorate, £475 a year:
 - (d) In the case of a member for a rural electorate, £550 a year.

- (3) For the purposes of this clause the Representation Commission established under the Electoral Act 1927 shall classify each electorate as—
 - (a) A Wellington electorate, being an urban electorate in or near to the City of Wellington or the City of Lower Hutt; or
 - (b) An urban electorate other than a Wellington electorate; or
 - (c) A partly rural electorate; or
 - (d) A rural electorate.
- (4) In classifying any electorate as aforesaid the Representation Commission shall take into account the size, topography, and transport facilities of the electorate, the nature of its roads, the distribution of its population, and all other considerations that the Commission deems relevant.

EXPLANATORY NOTE

[This note is not part of the order, but is intended to indicate its general effect.]

This order fixes the salaries and allowances to be paid to Ministers of the Crown, Parliamentary Under Secretaries, the Speaker and Chairman of Committees, the Leader of the Opposition, and other members of Parliament.

The rates are those recommended in the report of the Royal Commission recently laid before Parliament, and by virtue of section 27 (3) of the Civil List Act 1950 they are to supersede the rates provided for in Parts II, III, and IV of that Act.

The date of the commencement of the order is 1 September 1951.
