

THE PARLIAMENTARY SALARIES AND ALLOWANCES ORDER 1970, AMENDMENT NO. 1

Pursuant to sections 27 and 27a of the Civil List Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council and on the recommendation of the Prime Minister, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Parliamentary Salaries and Allowances Order 1970, Amendment No. 1, and shall be read together with and deemed part of the Parliamentary Salaries and Allowances Order 1970* (hereinafter referred to as the principal order).
- (2) This order shall be deemed to have come into force on the 1st day of April 1971.
 - 2. Parliamentary salaries—The principal order is hereby amended— (a) By omitting from paragraph (a) of clause 2 the words "\$17,000 a year", and substituting the words "\$19,040 a year":
 - (b) By omitting from paragraph (a) of clause 3 the words \$12,500 a year", and substituting the words "\$14,000 a year":
 - (c) By omitting from paragraph (a) of clause 4 the words "\$11,250 a year", and substituting the words "\$12,600 a year":
 - (d) By omitting from paragraph (a) of clause 5 the words "\$9,650 a year", and substituting the words "\$10,808 a year":
 - (e) By omitting from paragraph (a) of clause 6 the words "\$8,450
 - a year", and substituting the words "\$9,464 a year":

 (f) By omitting from paragraph (a) of clause 9 the words "\$10,000 a year", and substituting the words "\$11,200 a year":

 (g) By omitting from paragraph (a) of clause 100 the words "\$7,750
 - a year", and substituting the words "\$8,680 a year":

- (h) By omitting from paragraph (a) of clause 11 the words "\$10,500 a year", and substituting the words "\$11,760 a year":
- (i) By omitting from paragraph (a) of clause 12 the words "\$6,850 a year", and substituting the words "\$7,672 a year":
- (j) By omitting from paragraph (a) of clause 13 the words "\$6,600
- a year", and substituting the words "\$7,392 a year":
 (k) By omitting from paragraph (a) of clause 14 the words "\$6,400 a year", and substituting the words "\$7,168 a year":
- (1) By omitting from paragraph (a) of clause 15 the words "\$6,100 a year", and substituting the words "\$6,832 a year".
