## THE PARLIAMENTARY SALARIES AND ALLOWANCES ORDER 1970, AMENDMENT NO. 2

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to sections 27 and 27a of the Civil List Act 1950. His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council and on the recommendation of the Prime Minister, hereby makes the following order.

#### ORDER

1. Title and commencement—(1) This order may be cited as the Parliamentary Salaries and Allowances Order 1970, Amendment No. 2, and shall be read together with and deemed part of the Parliamentary Salaries and Allowances Order 1970\* (hereinafter referred to as the principal order).

(2) This order shall be deemed to have come into force on the 1st

day of April 1972.

- 2. Parliamentary salaries—The principal order (as amended by clause 2 of the Parliamentary Salaries and Allowances Order 1970, Amendment No. 1) is hereby further amended—
  - (a) By omitting from paragraph (a) of clause 2 the words "\$19,040 a year", and substituting the words "\$20,773 a year":
  - (b) By omitting from paragraph (a) of clause 3 the words "\$14,000 a year", and substituting the words "\$15,336 a year":
  - (c) By omitting from paragraph (a) of clause 4 the words "\$12,600 a year", and substituting the words "\$13,827 a year":
    (d) By omitting from paragraph (a) of clause 5 the words "\$10,808
    - a year", and substituting the words "\$11,894 a year":
  - (e) By omitting from paragraph (a) of clause 6 the words "\$9,464 a year", and substituting the words "\$10,444 a year":
  - (f) By omitting from paragraph (a) of clause 9 the words "\$11,200 a year", and substituting the words "\$12,316 a year":

(g) By omitting from paragraph (a) of clause 10 the words "\$8,680

a year", and substituting the words "\$9,598 a year":

(h) By omitting from paragraph (a) of clause 11 the words "\$11,760 a year", and substituting the words "\$12,921 a year":

- (i) By omitting from paragraph (a) of clause 12 the words "\$7,672 a year", and substituting the words "\$8,511 a year":
- (j) By omitting from paragraph (a) of clause 13 the words "\$7,392 a year", and substituting the words "\$8,209 a year":

(k) By omitting from paragraph (a) of clause 14 the words "\$7,168 a year", and substituting the words "\$7,967 a year":

(1) By omitting from paragraph (a) of clause 15 the words "\$6,832 a year", and substituting the words "\$7,604 a year".

3. Revocation—The Parliamentary Salaries and Allowances Order 1970, Amendment No. 1, is hereby revoked.

#### EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect. This order increases the rate of all parliamentary salaries. The order operates from 1 April 1972.

The increase is on a sliding scale, starting at the rate of 11.3 percent in the case of members and reducing to 9.1 percent in the case of the Prime Minister.
