ORDER IN COUNCIL

PURSUANT to section 27 of the Civil List Act 1950, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, and in accordance with the recommendations of a Royal Commission appointed in that behalf, as set out in the report laid before Parliament as parliamentary paper H. 2 of 1973, hereby makes the following order.

ORDER

- 1. Title and commencement—(1) This order may be cited as the Parliamentary Salaries and Allowances Order 1970, Amendment No. 4, and shall be read together with and deemed part of the Parliamentary Salaries and Allowances Order 1970* (hereinafter referred to as the principal order).
- (2) This order shall be deemed to have come into force on the 1st day of April 1973.
- 2. Parliamentary salaries—The principal order (as amended by clause 2 of the Parliamentary Salaries and Allowances Order 1970, Amendment No. 2) is hereby further amended—
 - (a) By omitting from paragraph (a) of clause 2 the words "\$20,773 a year", and substituting the words "\$27,500 a year":
 - (b) By omitting from paragraph (a) of clause 3 the words "\$15,336 a year", and substituting the words "\$21,000 a year":

- (c) By omitting from paragraph (a) of clause 4 the words "\$13,827 a year", and substituting the words "\$18,000 a year":
- (d) By omitting from paragraph (a) of clause 5 the words "\$11,894 a year", and substituting the words "\$15,500 a year":
- (e) By omitting from paragraph (a) of clause 6 the words "\$10,444 a year", and substituting the words "\$13,500 a year": (f) By omitting from paragraph (a) of clause 9 the words "\$12,316
- a year", and substituting the words "\$16,500 a year":

 (g) By omitting from paragraph (a) of clause 10 the words "\$9,598
- a year", and substituting the words "\$14,000 a year":

- 3. Revocation—The Parliamentary Salaries and Allowances Order 1970, Amendment No. 2, is hereby revoked.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order fixes new rates of salaries to be paid to Ministers of the Crown, Parliamentary Under-Secretaries, the Speaker, the Chairman of Committees, the Leader and Deputy Leader of the Opposition, the Whips, and other members of Parliament.

The rates are those recommended in the report of the Royal Commission laid before Parliament.

The order is deemed to have come into force on 1 April 1973.
